It has been specifically mentioned in the appointment letter that if later on it is found that she gets an appointment as Principal on the basis of furnishing false and fraudulent information, her services would liable to be terminated without any notice.

A complaint No. 116 of 2012 regarding furnishing of false document was filed by Sh. Vinod Tushir S/o Sh. Ajit Singh R/O Village Nangal Kalan Teh & Distt. Sonepat against Smt. Santosh Khatri, Principal before Lokayukta, whereby he alleged that she has got appointment as Principal on the basis of bogus teaching experience certificate. That complaint was got enquired from District Education Officer, Sonepat.

The enquiry officer submitted her enquiry report on 12.09.2012, wherein she concluded that Smt. Santosh Khatri while submitting application form for the post of Principal to Haryana Staff Selection Commission had attached experience certificate as TGT in English w.e.f. 21.07.1998 to 20.07.2007, but she had passed MA in 2nd Division only on 30.09.1998. Further, it was held by the enquiry officer that in the teacher attendance register of the concerned school, the delinquent officer has been shown working as English Master w.e.f. 21.07.1998 and as TGT English w.e.f. Sep, 2000. Whereas, the appointment letter as PGT English has been issued in April, 2003. Therefore, she has produced the bogus experience certificate.

In view of above, it is evident that

- (i) No appointment letter to the post of PGT English and Hindu Sr. Sec. School, Sonipat has been made available and only joining report dated 21.07.1998 has been submitted by you on the verbal directions of Manager of the school, as stated.
- (ii) In the experience certificates dated 22.12.2006 and 09.10.2007, it has been stated that you have been working in Hindu Sr. Sec. School, New Court Road, Sonepat as PGT English since 21.07.1998 in the pay scale of 6500-200-10500, whereas the same school vide reference No. HS/195/NCR dated 01.04.2003 have issued you an appointment letter as TGT to teach classes 6th to 9th w.e.f. 01.04.2003 in the grade of Rs. 6500-10500 and further confirmed on the said post w.e.f. 01.04.2004 vide letter No. HS/513/NCR dated 03.06.2004.

(iii) In the attendance register of the school for the month of July, 2000, your name has been shown at Sr. No. 33 with the designation of TGT English, whereas in the application form dated 19.07.2007, experience has been shown to the extent of nine years, without specific mention of category/designation, a show cause notice is issued to Smt. Santosh Khatri, Principal

Taking an overall view of the matter, I am provisionally of the opinion that a penalty of termination from service be imposed upon her. However, before taking action, I desire to give her an opportunity of showing cause against the action proposed to be taken. Any representation which she may like to make in this regard will be considered before the proposed action is taken. Such representation, if any, should be made in writing and submitted to the competent authority so as to reach not later then **fifteen days** from the receipt of this communication by her. In case of failure, it will be presumed that she has nothing to say in this regard and final order will be passed accordingly.
