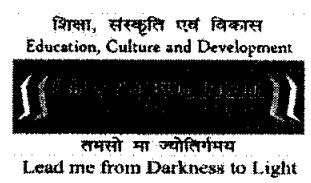

ORDER NO. 13/188 -2012 HRME (5)

Whereas Sh. Suresh S/o Sh. Ram Phool, Peon (Class IV), GHS , Ucha Majra (Gurgaon) had filed a CWP No. 15579 of 2012 in the Hon'ble Punjab & Haryana High Court and prayed therein to consider his name for promotion as Clerk w.e.f. date i.e. 28-06-2012 when junior to him, private respondent No. 3, was so promoted with all consequential benefits etc. The said writ petition came for hearing before the Hon'ble High Court on dated 09-10-2012 and the same was disposed of with the following directions:-

"Without going into the merits of the case or commenting thereon, this petition is disposed of with a direction to Director, School Education, Haryana respondent No. 1 to consider and decide the legal notice dated 02-07-2012 (Annexure P-3) within a period of Two months from the date of receipt of certified copy of this order. The decision so taken be conveyed to the petitioner forthwith.

In case, the petitioner is held entitled to the benefit as claimed by him through his legal notice dated 02-07-2012 (Annexure P-3), the consequential benefits be granted to petitioner within a further period of One month. If the claim as projected by the petitioner through his aforesaid legal notice is not to be accepted then a speaking and well reasoned order be passed by respondent No. 1 and the same be conveyed to the petitioner forthwith. "

That in compliance of the aforesaid directions of the Hon'ble Court, the legal notice of the petitioner has been considered and after going through the official record, it has been observed that the petitioner was initially appointed as Class IV joined on 20-11-1996 at GHS Bilaspur (Gurgaon). As per service rules the seniority of Group-D employee is maintained at institutional level and whenever an employee changes the institution he loses the earlier seniority and starts with a fresh seniority in the institution joined after transfer. Later on at his own request he was appointed on transfer basis at GHS Ucha Majra (Gurgaon) on 07-08-2008. The post of Class IV is an Institutional Cadre and the seniority of Class IV employees is to be maintained at the institutional level. Though, petitioner joined on 20-11-1996 but due to his fresh appointment by transfer to some other school, his new seniority was counted w.e.f. 07-08-2008 because he has lost his seniority on the post of earlier school due to appointment by way of transfer. The Department promoted the Class IV employees as Clerk who joined on regular basis up to 31-12-1997, but petitioner joined on 07-08-2008 after appointment by transfer.

Hence keeping in view the above facts, I am of the considered view that the representation made by the petitioner has no merit and the same deserves to be dismissed.

I order accordingly.

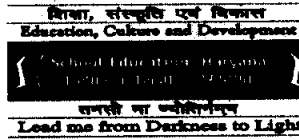

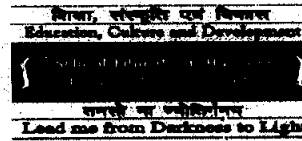
