The 7th May, 2013

No. 7/45-2010 PS(2). – In pursuance of the judgement dated 30-10-2002 of the Hon'ble Supreme Court of India in TMA Pai Foundation and others Versus State of Karnataka (2002 (8) SCC481), wherein the Hon'ble Court has observed that for the redressal of grievances of employees of unaided educational institutions who are subjected to punishment of termination of services, a mechanism will have to be evolved by constituting appropriate tribunals. The right of filing appeals would lie before the District and Sessions Judge or Additional District and Session Judge till the tribunals are set up.


Accordingly, District and Session Judges in the State of Haryana have been authorized to hear appeals of employees of aided/unaided technical education institutions against decision of management within their jurisdiction, by the Hon'ble Punjab and Haryana High Court Chandigarh vide No. 23414GAZ.II/IX.C.II, dated 10-08-200. The Tribunals already notified by the Hon'ble High Court will also hear appeals of employees of aided/unaided schools against the orders of management.





Smt. Shikha Sharma, [96426] Clerk O/o 15 Haryana Bn NCC, Jind is hereby selected for temporary appointment as Clerk in the office of Headmaster, Govt. Girls Middle School Dablain [4774] (Jind) on transfer basis in the grade of Rs. 5200-20200+GP 1900/-.

Her pay will be fixed in the grade according to rules. She will also draw the usual allowances admissible to Govt. Servants of their categories issued from time to time.

Her appointment in the office of Headmaster, Govt. Girls Middle School Dablain (Jind) will be on the following terms and conditions:-

1. Her appointment is against purely temporary post, which is liable to be abolished at any time and carries no promise of subsequent permanent employment. As such, as and when there will be no vacancy against which she could continue to officiated in the 15 Haryana Bn NCC, Jind O/o Directorate of Higher Education Haryana she will be reverted to her parent office. It is, thus made clear to her that at present she has been offered temporary post.
2. In case at any stage, while she remains in temporary capacity desire to resign her post she will be required to give one month notice or forfeit in lieu thereof salary including allowances for one month or for the period by which the notice falls short of one month. Such a notice will be given to her by the Department also in case it is proposed to terminate her service for reasons other than those mentioned in Para-I above. The Department will also be liable to pay salary including allowances for one month or for the period by which the notice falls short of one month. In case of misconduct, however, she will be entitled to a reasonable opportunity to show cause notice as to why her service should not be terminated, in that case the condition of one month notice shall not apply. Her services will be governed by the Haryana Education Department Sub Offices Ministerial Cadre (Group-C) Service Rules 1983 as amended form time to time.
3. She will be on probation for a period of two year from the date of joining. If her work and conduct is not found satisfactory, she will be reverted to her parent cadre without giving any notice to her.
4. In case she is married, she would have only one living spouse, if she has more than one living spouse, she should justify for that.
5. She will be given seniority as per Rule 11 of the Haryana Education Department Sub Office Ministerial Cadre (Group-C) Service Rules 1983 as amended from time to time. She will be assigned seniority from the date she joins in the Field Office and will be placed at the tale-end of the employees already appointed in the Field Offices.

6. If she has passed the type test already as per their service condition in her parent Department, she would get increment usually provided that there should be entry in this regard in her service book. Otherwise she will have to pass type test in Hindi/English at the speed of 25/30 words per minute respectively within a year after joining in the school. Till she passes the said type test she will not be allowed increment until she passes such test. After passing the type test she will be allowed the due annual increment (s) following the date from passing the test but no arrear will be allowed.
7. No T.A./D.A. will be allowed to her for joining this post.
8. Her services will be governed under the new Pension Scheme of the Haryana Govt.
9. She will not undertake higher studies of any kind without prior permission of the competent authority consequently no leave of any kind will be granted for the prosecution of higher studies.

If she is willing to accept the offer made on the above mentioned conditions, she may get herself be relieved and report for duty to the office of **Headmaster, Govt. Girls Middle School Dablain (Jind)** within a period of 15 days from the date of issue of this letter.

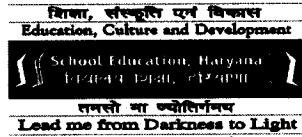

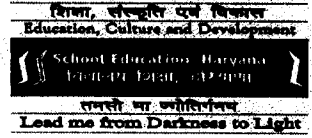
