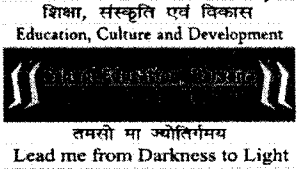

**Speaking order**

Order No.: 17/180 → 2 HR (M E C I) Dated Panchkula, the 14.5.13

Ms. Sunita Sharma, Science Mistress, GSSS Ramgarh, Ms. Savinder Kaur, Social Science Mistress, GSSS Kalka and Ms. Lalita Gullia, Social Science Mistress, Govt. Middle School Tipra (Panchkula) had preferred a Civil Writ Petition No. 16415 of 2012 titled Sunita Sharma & others versus State of Haryana & others before Hon'ble Punjab & Haryana High Court at Chandigarh under Article 226 of the Constitution of India for issuance of a writ of mandamus to the respondents granting seniority to the petitioners for pre-regularization service, they rendered in a manner given to other similarly situated employee vide order dated 25.07.2012. The writ petition came for hearing before Hon'ble High Court on 09.10.2012 and the Hon'ble High Court pleased to issue directions to respondents. The operative part of the judgment dated 09.10.2012 is reproduced here for ready reference:

**"In the light of the statement made by the counsel for the petitioners, present petition is disposed of with liberty to the petitioners to submit a representation to the Director, Secondary Education, Haryana respondent No. 3 within a period of four weeks from today, claiming the benefit as has been claimed by them in the present petition.**

**If such a representation is made to the Director, Secondary Education, Haryana-respondent No. 3, the same shall be decided by the said respondent within a period of five months of submission of such representation. Decision so taken be conveyed to the petitioners forthwith."**

In pursuance of directions dated 09.10.2012 issued by Hon'ble High Court and the representation dated 25.10.2012 submitted by the petitioners, the service record of the petitioners was sought. It is found that the claim of seniority as claimed is similar to Sh.Ramkaran, Math Master, GHS Bunga (Panchkula). Further, it is worthful to submit here that Sh. Ram Karan, Math Master, GHS Bunga (Panchkula) was granted the benefit of seniority in master cadre seniority list as stood on 01.01.2006 after counting the adhoc service vide order No. 17/28-2008 HRM-1(1) Dated 25.07.2012, **but subject to the decision/ order of Hon'ble Supreme Court of India in SLP No. 29274 of 2009 titled State of Haryana versus Vijay Singh & others.** The Hon'ble Supreme Court of India has now settled the controversy vide judgment dated 22.08.2012. The effective part of the judgment dated 22.08.2012 is reproduced here for ready reference:

"24. None of the aforesaid judgments can be read as laying down a proposition of law that a person who is appointed on purely ad hoc basis for a fixed period by an authority other than the one who is competent to make regular appointment to the service and such appointment is not made by the specified recruiting agency is entitled to have his ad hoc service counted for the purpose of fixation of seniority. **THEREFORE, THE RESPONDENTS, WHO WERE APPOINTED AS MASTERS IN DIFFERENT SUBJECTS, PHYSICAL TRAINING INSTRUCTOR AND HINDI TEACHER ON PURELY ADHOC BASIS WITHOUT FOLLOWING THE PROCEDURE PRESCRIBED UNDER THE 1955 RULES ARE NOT ENTITLED TO HAVE THEIR SENIORITY FIXED ON THE BASIS OF TOTAL LENGTH OF SERVICE.** As a corollary to this, we hold that the direction given by the High Court for re-

**fixation of the respondents' seniority by counting the ad hoc service cannot be approved.**

**25. In the result, the appeal is allowed, the impugned order is set aside and the writ petition filed by the respondents is dismissed. The parties are left to bear their own costs."**

In compliance of this above mentioned judgment dated 22.08.2012 of Hon'ble Apex Court of India, the benefit granted to Sh. Ramkaran, Math Master, GHS Bunga (Panchkula) vide order No. 17/28-2008 HRM-1(1) Dated 25.07.2012 has already been withdrawn vide order No. 17/28-2008 HRM-1(1) Dated 15.10.2012, therefore, the petitioners, being a similarly situated Mistresses are not entitled to any benefit of seniority in the master cadre. The representation dated 29.07.2012 has no merits; therefore, the claim for seniority is, hereby, declined.

Ms. Sushila Sharma, Hindi Teacher, GSSS Kalka and Ms. Surekha, Social Science Mistress, GSSS Ramgarh (Panchkula) had preferred a Civil Writ Petition No. 21669 of 2012 titled Sushila Sharma & another versus State of Haryana & others before Hon'ble Punjab & Haryana High Court at Chandigarh under Article 226 of the Constitution of India for issuance of a writ of mandamus to the respondents granting seniority to the petitioners for pre-regularization service, they rendered in a manner given to other similarly situated employee vide order dated 25.07.2012. It is worthwhile to mention that this order relates to 2<sup>nd</sup> petitioner i.e. Ms. Surekha only. The writ petition came for hearing before Hon'ble High Court on 01.11.2012 and the Hon'ble High Court pleased to issue directions to respondents. The operative part of the judgment dated 01.11.2012 is reproduced here for ready reference:

**"Without going into the merits of the case or commenting thereon, this petition is disposed of with a direction to the Director, Secondary Education Haryana-respondent-respondent No. 3 to consider and decide the representation dated 29.7.2012 (Annexure-P-7), submitted by the petitioners, within a period of three months from the date of receipt of certified copy of this order. The decision so taken be conveyed to the petitioners forthwith."**

In pursuance of directions issued by Hon'ble High Court, the service record of the 2<sup>nd</sup> petitioner was sought with representation dated 29.07.2012. It is worthful to submit here that Sh. Ram Karan, Math Master, GHS Bunga (Panchkula) was granted the benefit of seniority in

master cadre seniority list as stood on 01.01.2006 after counting the adhoc service vide order No. 17/28-2008 HRM-1(1) Dated 25.07.2012, but subject to the decision/ order of Hon'ble Supreme Court of India in SLP No. 29274 of 2009 titled State of Haryana versus Vijay Singh & others. The Hon'ble Supreme Court of India has now settled the controversy vide judgment dated 22.08.2012. The effective part of the judgment dated 22.08.2012 is reproduced here for ready reference:

***"24. None of the aforesaid judgments can be read as laying down a proposition of law that a person who is appointed on purely ad hoc basis for a fixed period by an authority other than the one who is competent to make regular appointment to the service and such appointment is not made by the specified recruiting agency is entitled to have his ad hoc service counted for the purpose of fixation of seniority. THEREFORE, THE RESPONDENTS, WHO WERE APPOINTED AS MASTERS IN DIFFERENT SUBJECTS, PHYSICAL TRAINING INSTRUCTOR AND HINDI TEACHER ON PURELY ADHOC BASIS WITHOUT FOLLOWING THE PROCEDURE PRESCRIBED UNDER THE 1955 RULES ARE NOT ENTITLED TO HAVE THEIR SENIORITY FIXED ON THE BASIS OF TOTAL LENGTH OF SERVICE. As a corollary to this, we hold that the direction given by the High Court for re-fixation of the respondents' seniority by counting the ad hoc service cannot be approved.***

***25. In the result, the appeal is allowed, the impugned order is set aside and the writ petition filed by the respondents is dismissed. The parties are left to bear their own costs."***

In compliance of this above mentioned judgment dated 22.08.2012 of Hon'ble Apex Court of India, the benefit granted to Sh. Ramkaran, Math Master, GHS Bunga (Panchkula) vide order No. 17/28-2008 HRM-1(1)

Dated 25.07.2012 has already been withdrawn vide order No. 17/28-2008 HRM-1(1) Dated 15.10.2012, therefore, the 2<sup>nd</sup> petitioner i.e. Ms. Surekha, being a similarly situated SS Mistress is not entitled to any benefit of seniority in the master cadre. The representation dated 29.07.2012 has no merits; therefore, the claim for seniority is, hereby, declined.

I pass this order accordingly.
