In compliance of the order passed by Hon'ble Court in CWP No. 17558 of 1999, Satish Kumar Vs State dated 07.05.2012. Sh. Satish Kumar S/o Sh. Ram Singh, resident of VPO Bhudhera, Bhiwani [Employee ID: 096427] is hereby appointed as Lecturer History w.e.f. 27/09/1999 in GSSS Karora (Kaithal) [2181] with all consequential benefits except monetary benefits in the pay scale of Rs. 9300-34800 + Grade Pay 4800/- plus usual allowances as admissible under the State Government Rules from time to time. The candidate is directed to join his place of posting mentioned against his name within 15 days from the date of receipt of this order on the following terms and conditions:-

Terms and conditions:-

1. He is appointed purely on temporary basis.
2. This appointment is against temporary posts and his confirmation against substantive posts shall be considered on the basis of his seniority and record of service as and when such post is available.
3. He shall have to take an oath of allegiance to the constitution of India.
4. He shall produce a certificate before joining the duties to the effect that he has one living wife/husband in case he/she is married. If he has not more than one living wife/ husband, shall be eligible for appointment to the post offered unless the Government after being satisfied that there is special grounds for doing so, exempt them from this condition.
5. He shall not be allowed to apply for any post outside that department for a period of at least five years.
6. His inter- seniority will also be decided in accordance with the service rules and instructions of the State Government issued from time to time.
7. He shall be on probation for a period of two years, the period of probation can be extended for a further period not exceeding one year, if considered necessary.
8. In other matters, not specifically mentioned in this communication, he shall be governed by the civil services Rules as applicable to Haryana Government Employees and such orders/ instructions as may be issued by the Government from time to time.
9. Candidate who has been selected as Lecturer is hereby directed to submit his original certificates of academic qualification and other relevant certificate with the concerned District Education Officer of his place of posting. DEO will ensure that the candidates produces medical fitness certificate issued by the Medical Board. Only then he would be allowed to join as Lecturer in respective schools of

posting. District Education Officer will also give character and antecedent verification forms to them and after filling the forms, the candidates would submit them to the DEO concerned immediately.

10. He will be governed by the Service Rule as applicable from time to time.
11. If at any time during the course of their temporary appointment, any of the appointee desires to resign, they shall be required to give one month's clear notice or forfeit, in lieu thereof, their salary including allowances etc. for one month or for the period by which the notice falls short of one month. Such a notice will be given to him/her by the Government also in the case it is proposed to terminate his/her services in lieu thereof the Government will be liable to pay him/her salary, including allowances for one month or for the period by which the notice falls short of one month.
12. No TA/DA will be admissible to the candidates for joining as Lecturer.


