2. No TA/DA and joining time will be admissible to the official if he/she has been shifted on his/her request after exercising option.
3. No male teacher below the age of 50 years be allowed to join in the girls schools.
4. **If there is no vacancy in the destination school for any reason the incumbent transferred shall re-join his/her previous place of posting and also inform to concerned branch/computer cell at HQ.**
