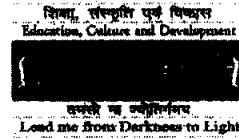

Sh. Kapil Kumar Punia, the then Principal, GSSS Birghana (Jhajjar) now working at GSSS Chamarian (Rohtak) was charge sheeted under Rule-8 of Punishment & Appeals rules, 1987 vide order No. 5/200-2010 HRG-I (1) Dated, 31.07.2012, wherein following charges were leveled against him:-

“यह कि उप निदेशक कम जांच अधिकारी से प्राप्त रिपोर्ट दिनांक 22.12.2010 के अनुसार श्री कपिल कुमार पुनिया, द्वारा श्री शान्ति प्रकाश, गणित अध्यापक के साथ लड़ाई-झगडा करके विद्यालय में पार्टी बाजी का माहौल पैदा किया। जिससे बच्चों की पढाई में बाधा उत्पन्न हुई और विद्यालय में पढाई सुचारु रूप से नहीं चल सकी।

यह कि उन द्वारा श्री शान्ति प्रकाश गणित अध्यापक की पढाई हेतु छुट्टी स्वीकृत की जिसके लिए वह सक्षम नहीं थे। ”

He replied to the charge sheet on 25.08.2012 and denied the charge leveled against him.

From the face of the record before me and reply submitted by delinquent Principal, it is evident that Sh. Shanti Parkash, Math Master was granted permission for doing Ph.D. in Mathematics from University of Wales Swansea (U.K.) in the year 2009. He has applied for extra ordinary leave from 03.04.2005 to 15.04.2005 on 02.04.2005 through the Principal, but Shri Kapil Kumari Punia, Principal himself in connivance with the Shri Shanti Parkash granted him study leave instead of extraordinary leave vide its letter No. 739/2004 dated 24.12.2004. He had also relieved Sh. Shanti Parkash, Math Master at his own level vide letter No. 771/2005 dated 02.04.2005. Thus, Sh. Shanti Parkash, Math Master remained absent from duty.

On other hand after joining services, after suspension, Shri Shanti Parkash, Math Master again started to make correspondence to get the EOL of 3 years 13 days regularized in the year 2009. Making no headway, he started making trouble for the Principal and other staff members of the school. He also pressurized the Principal to make entries in the service book to get the claim matured. No doubt, the said Math Master was the bone of contention in the school. However, the Principal too cannot be escaped his responsibility. He should not have sanctioned the study leave to Shri Shanti Parkash, Math Master and altered the nature of leave after flouting the leave rules mentioned under CSR Vol.I Part.I at his own level for which he was not competent. The Principal found himself at fault for a wrong act. Later the Principal took the help of police for getting FIR registered against the said Master. Thus, the environment of the school remained vitiated for which he was also responsible.

But taking a lenient view, penalty of stoppage of one increment without cumulative effect is imposed on him for sanctioning the study leave unauthorizedly.
