2. The school shall be open for study as per syllabus prescribed by the concerned board.
3. The school shall be open as declared by the school and shall not be closed for any reason during the academic session. In case of any change in the fee structure, the school shall inform the appropriate authority, one month in advance for the next academic year and will also issue printed receipts of fees/dues to the students.
