Civil Writ Petition No. 19370 of 2009 had been filed by the petitioner i.e. Ram Kanwar Khola in Hon'ble Punjab & Haryana High Court for seeking the direction to the respondents to release Rs. 2,44,499/- of Medical Reimbursement to the petitioner which have been incurred by him on his treatment while he was posted as Math Master. The above cited writ petition had been disposed of with the following direction vide order dated 16.12.2009:

"In view of the above, this petition is disposed of with a direction to Respondent No. 2 to consider the claim of the petitioner for medical reimbursement and take a decision on the representations referred to here-in- above in accordance with law within a period of two months from the date a certified copy of this order is furnished to the competent authority. If the petitioner is found entitled to any claim, the same be released to him in accordance with law within a period of one month thereafter. Needless to say, in the event the claim of the petitioner is to be rejected, it shall be by a reasoned and speaking order."

In compliance of orders passed by Hon'ble High Court, the said representations i.e. Annexure P-4 (dated 21.09.2004) and Annexure P-5 (dated 18.11.2004) have been considered. The contents of the representations submit as under:

1. That the petitioner was working on the post of Math Master at Govt. Senior Secondary School, Berli Khurd, District- Rewari. The petitioner got his superannuation on 28.02.2006.
2. That during his service, the petitioner suffered with "Gulian Bery Syndrom" disease. He remained admitted for his treatment in Sir Ganga Ram Hospital, New Delhi from 18.02.2002 to 09.03.2002 and incurred a medical expenditure of Rs. 244499/-.
3. That the petitioner submitted medical reimbursement claim of Rs. 244000/- approximately before District Education Officer, Rewari vide Memo No. 3711/03 dated 16.09.2003 of his school. The same was forwarded to the Director School Education Haryana Chandigarh vide D.E.O. Rewari letter Lekha-1/03/Original-2741/886 Dated 15.10.2003.
4. That the said medical reimbursement claim was sent back to Govt. Senior Secondary School, Berli Khurd, District- Rewari with some objections through District Education Officer, Rewari. Further O/o- District Education Officer, Rewari forwarded the same to school vide letter No. 2601/19 dated 20.01.2004.

That the petitioner had taken his treatment at Sir Ganga Ram Hospital, New Delhi which was an unapproved hospital at the time of treatment. That hospital was declared approved for treatment vide Health Department Haryana, Chandigarh Memo No. 2/29-86-I HB II dated 31.10.2002, after eight months, from the date when the petitioner had taken his treatment in Sir Ganga Ram Hospital, New Delhi. It means, that the petitioner had taken his treatment at an unapproved hospital and he had not fulfilled the requirement as per Punjab Medical Attendance Rules, 1940 and regulations/instructions issued from time to time by the State Govt. In the old rules, prior to New Reimbursement Policy, 2005, there was no provision of "Emergency Certificate from Concerned Civil Surgeon" for reimbursement of the treatment taken from an unapproved hospital. Thus he is not entitled to reimbursement of treatment taken from an unapproved hospital.

It is further submitted that as per Haryana Govt. Memo No. 2/401-I HB III-80 dated 06.03.1980, the time limit for preferring the medical claims for the amount incurred by Govt. employees/officers on their own treatment or on the treatment of their dependants had been raised from 3 months to 6 months. The period of six months for this purpose will be counted from the date of completion of the treatment. In pursuance of these instructions, the treatment of the petitioner was completed on 09.03.2002 but as per Annexure P-4, he had submitted his medical reimbursement claim on 16.09.2003 i.e. approximately 01 year and 06 months later. Thus the matter is time barred and not covered supra instructions dated 06.03.1980. **In Inder Pal Khod vs. State of Haryana, 2000(2) SCT 981 wherein bills were submitted late and then it was held that the respondent-State was justified in rejecting the claim when the bills were not submitted within stipulated time.**

That Hon'ble High Court, Delhi in **Shri M.L. Kamra vs Lt. Governor and Others., 98 (2002) DLT 97, 2002 (64) DRJ 207** has held as under:

"35. Now I turn to the last limb of the argument of the counsel for the petitioner. It is submitted that the petitioner is a poor employee and he had incurred a huge sum on his treatment at Apollo Hospital and reimbursement, at least, should be granted at the same scale at which he was entitled for it to be granted had he taken the treatment at a government hospital like AIIMS or even the G.B. Pant Hospital. Considering the huge amount spent by the petitioner the prayer of the petitioner seems innocuous at the first glance. However, if such reimbursement was allowed it would open Pandora's box. The rules have been framed by the State Government for providing

medical facilities to its servants keeping in view the financial resources, need and other constraints of the State Government. These rules are reasonable and cannot be held to have denied the government servant of fair and adequate medical facilities. If the petitioner in contravention of the CS (MA) Rules or the government circulars take a treatment at a place of his choice and he is reimbursed the medical claim at the rates which are applicable for treatment in government hospitals it would open a flood gate of medical reimbursement claims from its employees which may not be good for its financial resources. The government has established the hospitals, spends huge sum on their maintenance, it has recognised certain private hospitals also in consultation with the experts and keeping in view of its own financial resources. The violation of such rules, therefore, cannot be allowed to be made even in exception."

Further, the Supreme Court in State of Punjab and others Vs. Ram Lubhaya (1998 A.I.R. (SC) 1703) while dealing with the new policy of the Government of Punjab which disallowed reimbursement of the full medical expenses incurred by an employee of the Punjab Government for such treatment in any hospital in India not being a government hospital in Punjab, in para-25 observed:

"So far as questioning the validity of governmental policy is concerned in our view it is not normally within the domain of any court, to weigh the pros and cons of the policy or to scrutinize and test the degree of its beneficial or equitable disposition for the purpose of varying, modifying or annulling it, based on howsoever sound and good reasoning, except where it is arbitrary or violative of any constitutional, statutory or any other provision of law. When Government forms its policy, it is based on a number of circumstances on facts, law including constraints based on its resources. It is also based on expert opinion. It would be dangerous if court is asked to test the utility, beneficial effect of the policy or its appraisal based on facts set out on affidavits. The court would dissuade itself from entering into this realm which belongs to the executive."

In para 29 of the judgment the Supreme Court further laid down:

"No State of any country can have unlimited resources to spend on any of its projects. That is why it only approves its projects to the extent it is feasible. The same holds good for providing medical facilities to its citizen including its employees. Provision of facilities cannot be unlimited. It has to be to the extent finances permit. If no scale or rate is fixed then in case private clinics or hospital increases their rate to exorbitant scales, the State would be bound to reimburse the same. Hence we come to the conclusion that principle of fixation of rate and scale under this new policy is justified and cannot be held to be violative of Article 21 or Article 47 of the Constitution of India."


It is submitted that the "New Reimbursement Policy, 2005" came into existence w.e.f. 06.05.2005 and there is no retrospective effect therein, therefore, the provisions of New Reimbursement Policy cannot be implemented on a treatment held in the year, 2002.

It is further submitted that the answering respondent believes in administration of justice and keeps utmost faith in the orders/ judgments passed by this Hon'ble Court. But keeping in view, Medical Reimbursement Rules and instructions issued by the Govt. of Haryana time to time prior March, 2002, and thereafter pursuing the various judgments of the Hon'ble High Court read with the judgments of Hon'ble Supreme Court of India, the petitioner's claim for reimbursement of his medical expenses is not sustainable. The representations dated 21.09.2004 and 18.11.2004 has no merits, therefore, the same deserve to be declined.

I pass an order accordingly.
