
Whereas, Smt. Archana Sehgal, the then Principal, GSSS Badya Brahmana (Hisar) now posted as BEO Uklana (Hisar) was charge sheeted under Rule-8 of Punishment & Appeals rules, 1987 vide order No. 5/65-2012 HRG-I (1) Dated, 06.09.2012, wherein following charges were leveled against her :-

I have gone through the relevant record of the case and found that explanation of delinquent officer is not wholly unjustified. However, by taking a lenient view, I pass an order to drop the charge sheet under Rule-8 against Smt. Archana Sehgal, the then Principal, GSSS Badya Brahmana (Hisar) now BEO Uklana (Hisar).

I order accordingly.

If any discrepancy is noticed in this order or there is a violation of transfer policy, It should be brought to the notice of Computer Cell/Concerned branch within three days and the order be not implemented.
5. In case of mutual transfer, it is directed that before relieving/joining the officials concerned, it may be ensured that the distance between both the schools is not less than 8 km.
6. In case of urban area stations while implementing the transfer orders, it may be ensured that the transferee has completed the rural service as per transfer policy.
7. **The mutual transfer would be effective only when both the employees seeking mutual transfer submit a consent document to their respective Principals.**

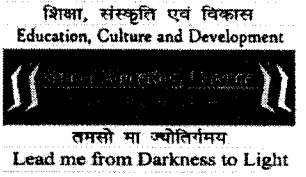
