**BOTH THE PARTIES HAVE HEREBY MUTUALLY AGREED TO THE FOLLOWING:**

1. The services of a person engaged by the Department will remain operative till **31.05.2014** or existence of the Pilot Project under NVEQF, whichever is earlier & subject to satisfactory performance on a consolidated remuneration of Rupees 25,000/- p.m.;

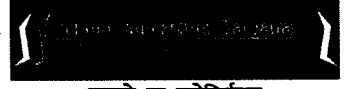
