Whereas Smt. Aarti Verma, the then Principal, Govt. Sr. Sec. School Raipur Rani (Panchkula) now posted as Principal, Govt. Girls Senior Secondary School, Sec-15, Panchkula was charge sheeted under Rule-8 of Haryana Civil Services (Punishment & Appeal) Rules, 1987 vide order dated 06.09.2012, wherein following charges were levelled against him :-

Smt. Aarti Verma submitted her reply to the charge sheet on 24.9.2012 and denied all the charges levelled against her. In her reply she contended that appointment issued to Smt. Snigdha, Guest Lecturer is as per Civil Services Rules, because the qualification possessed by the applicant was as per UGC norms. The degree obtained by the applicant from Banasthali Vidhya Peeth (Rajasthan) is recognized as deemed university by UGC under section 3 of the UGC Act 1956.

Comments of DEO Panchkula were also sought. The DEO is of the view that reply of delinquent is satisfactory. Thereafter, an opportunity of personal hearing was granted to the delinquent on 28.01.2014. At the time of personal hearing, she reiterated the same facts which she has explained in her reply to the charge sheet.

After going through all the facts and record of the case, it has been found that the reply of the delinquent is satisfactory as contents of her reply regarding qualifications possessed by Smt. Snighda (Guest Teacher) from Banasthali Vidhya Peeth (Rajasthan) have been verified from the website which found correct. Therefore, I order to drop the charge sheet under Rule-8 against Smt. Aarti Verma, Principal, Govt. Girls Senior Secondary School, Sec-15, Panchkula.





Smt. Kiranjeet Kaur, Principal, GSSS Lalheri Kalan (Yamuna Nagar), while being posted at Government Senior Secondary School Bilaspur (Yamunanagar) was chargesheeted vide Order No. 5/103-2011 HRG-I(1)/2432 dated 13.02.2013 under Rule 7 of Haryana Civil Services (Punishment and Appeal) Rules, 1987 on the following charges:-

That she remained absent from duty from 01.07.2011 till 25.09.2012/12.10.2012 without departmental permission.

She replied to the said chargesheet on 08.07.2013, wherein she stated that she applied for voluntary retirement on 27.05.2011 due to the serious illness of her husband but the same was not sanctioned, inspite of the fact that she has made repeated requests in the matter to District Education Officer for waiving the notice period. She also enclosed medical subscription dated 25.04.2011 made by Dr. B. K. Gupta, Neurologist, Pushpanjali Health Care, Ghaziabad regarding the illness of her husband. She further stated that when voluntary retirement was not granted to her, she requested on 21.08.2012 to allow her to join duties and accordingly vide order dated 25.09.2012, she was allowed to join at GSSS Lalheri Kalan, Yamunanagar. She was heard in person on 17.04.2014.


During personal hearing, she submitted that she remained absent due to the serious illness of her husband having a neurology problem and she has performed her duties with complete dedication and commitment during the entire service. She further submitted that when even voluntary retirement was not granted to her, inspite of making time and again requests, there was no option left with her to remain absent, in view of the family circumstances enunciated above.

I have gone through the contents of the file, chargesheet, reply thereof, submissions made at the time of personal hearing and connecting provisions of Haryana Civil Services (Punishment and Appeal) Rules, 1987. It is evident that the charge of remaining absent is proved on the face of the chargesheet. However, it is equally true that the department has failed to take timely decision about her voluntary retirement. Further, it is also true that the incumbent remained absent due to the illness of her husband of being involved

in a neuro problem. However, this fact can also not be denied that she has failed to establish that she has applied for leave to the competent authority. Hence the charge is proved to the said extent.

Taking a lenient view in the matter and peculiar circumstances of the case and superannuation of the incumbent due on 30.06.2014, a penalty of 'censure' is inflicted upon Smt. Kiranjeet Kaur, Principal, GSSS Lalheri Kalan (Yamuna Nagar), as provided in Clause (e) of Sub Rule (2) of Rule 7, read with Rule 4(1)(ii) of Haryana Civil Services (Punishment and Appeal) Rules, 1987. Further, the incumbent shall not be entitled for any re-employment after 30.06.2014 on account of her superannuation in the department. Furthermore, the absence period from 01.07.2011 till 25.09.2012/12.10.2012 shall not be counted for any pensionary benefits. However, necessary relaxation in Rule 8.137 of The Punjab Civil Services Rules Volume-I Part-I as applicable to Haryana, of getting extraordinary leave for the said absence period sanctioned from Finance Department, will be obtained by the department.

I order accordingly.


