1. That he remained absent from duties from 01.05.2005 to 09.04.2008 continuously without any information and without prior sanctioned leave. In spite of reminder, he did not explain his position.
2. That he again continuously remained absent from duties from 06.05.2010 without giving any information and without prior sanctioned leave from competent Authority.

After receipt of reply from Sh. Rajpal Sc. Master, it was considered and found not satisfactory, thereafter Sh. R.C. Sharma HCS (Retd) was appointed as inquiry officer vide this office order No 15/106-08 HRMI (5) dated 01.03.2012. Notice was issued by the inquiry officer to Sh. Raj Pal, Science Master. In compliance of the Notice issued, presenting officer and the delinquent joined the enquiry proceeding. Sh. Raj Pal Singh, Science Master pleaded not guilty of the charges levelled against him and choose to contest the same. On various hearing's, the departmental witness/evidence remained present in the enquiry but the delinquent did not attend the enquiry. At last, the enquiry was concluded ex-parte on 13.07.2012. Ultimately inquiry report was submitted on 20.7.2012 by inquiry officer in which charges leveled against Sh. Rajpal, Science Master stood proved.

After examining this enquiry report, a copy of said enquiry report was sent to delinquent vide Regd. Letter No 15/106-08 HRMI (5) dated 19.12.12. A Reminder was also sent through registered post on 23.05.2013 & 23.10.2013. Principal of GSSS Kheri Talwana (M.Garh) was also sent a copy of the enquiry report and further directed to get received reply from the delinquent. The principal deputed school chowkidar to intimate the delinquent and received its reply. The chowkidar visited the house of delinquent but delinquent was not present at his house. The delinquent's wife refused to receive the intimation. Her refusal has been duly verified by the Sarpach of the village. After due information the delinquent neither submitted any objection against the enquiry report nor submitted any representation. It seems that the delinquent employee is not interested in doing his duties and deserve to be dismissed from service.

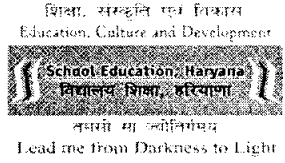

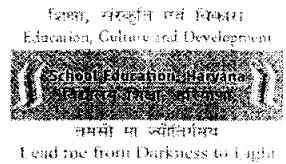

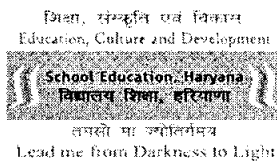
