SHOW CAUSE NOTICE

No. 5/95-2012 HRQFC/11

Dated: 28-3-14

Whereas Ms. Vidyawati D/o Sh. Indersen R/o Sundana (Rohtak) was appointed as Lecturer in History, in view of recommendation made by Subordinate Services Selection Board, Haryana vide order No. 15/167-88-E.IV(3) dated 25.01.1989. Further a complaint dated 24.01.2013 was received by the Government for wrong selection of the incumbent being married woman in the quota of dependent of ex-serviceman, wherein it was mentioned that the said Smt. Vidya Dhaka, Principal was married to Sh. Dharamvir S/o Sh. Ratti Ram R/o Village Bhagvi (Bhiwani) in June, 1977. A fact finding inquiry was got conducted, wherein it has been concluded that Smt. Vidya was married with Sh. Dharamvir Singh R/o Village Bhagvi, Tehsil Dadri in July, 1980. It was further concluded that two sons were born out of the said wedlock on 27.01.1984 and 16.01.1991. Accordingly, it is clear that the incumbent was married at the time of her appointment on 20.09.1989 and was not entitled for appointment in the quota of dependent of Ex-servicemen of her late father. Since initial appointment of Smt. Vidya Dhaka was void *ab initio*, thus his subsequent promotion as Principal on the basis of his initial appointment cannot be termed as valid and legally sustainable.

As per terms and conditions of appointment in the application form, while applying for the post, it is provided that in case any

certificate or qualification is found bogus later on as a consequence of enquiry or otherwise, the appointment shall stand terminated without giving any notice. However, in the interest of justice, I desire to give the incumbent an opportunity of showing cause against the action proposed to be taken. Any representation, which she may like to make in this regard, will be considered before the proposed action is taken. Such representation, if any, should be made in writing and submitted to the competent authority so as to reach not later than fifteen days from the receipt of this communication by him. In case of failure, it will be presumed that she has nothing to say in this regard and final order will be passed accordingly.
