

SHOW CAUSE NOTICE

Whereas Smt. Darshana Kumari, presently posted as Principal, GSSS Gignao (Bhiwani) was appointed as Social Studies Mistress vide order No. 24/4-2003 E-II (1) dated 23.10.2003 in Physical Handicapped quota. While applying for the post of Social Studies Mistress, she attached with the application form her certificate of 100% disability. Whereas, State Vigilance Bureau in the inquiry report has not found any disability of the incumbent. Thus, FIR No. 2 dated 10.02.2010 u/s 420/467/468/471/120-B & 13(1) the Prevention of Corruption Act, 1988 was registered against her. Since initial appointment of Smt. Darshana Kumari was void *ab initio*, thus her subsequent direct appointment as Headmistress on the basis of her experience certificate as Social Studies Mistress and further promotion as Principal cannot be termed as valid and legally sustainable.

 It is a statutory condition in every appointment in a public service that in the eventuality of appointment of bogus certificate, the same shall be terminated forthwith. After going through the facts and evidence on record, it has been established beyond doubt that Smt. Darshana Kumari got the job of Social Studies Mistress in the year 2004 on the basis of bogus disability certificate in handicapped quota, whereas she was not handicapped at all.

As per terms and conditions of appointment in the application form, while applying for the post, it is provided that in case any certificate or qualification is found bogus later on as a consequence of enquiry or otherwise, the appointment shall stand terminated without giving any notice. However, in the interest of justice, I desire to give the incumbent an opportunity of showing cause against the action proposed to be taken. Any representation, which she may like to make in this regard, will be considered before the proposed action is taken. Such representation, if any, should be made in writing and submitted to the competent authority so as to reach not later than fifteen days from the receipt of this communication by her. In case of failure, it will be presumed that she has nothing to say in this regard and final order will be passed accordingly.
