



Whereas, Hon'ble Punjab & Haryana High Court in CWP No. 10470 of 2013 titled as Nirmala Devi Versus State of Haryana & Others vide its interim order dated 28.01.2014 has directed as under:-

“Counsel for the State is directed to seek instructions from the Principal Secretary Education to Haryana Government, to explore the possibility of posting the petitioner at a place in or around Nathupur.

At this stage, counsel for the State submits that the petitioner and respondent No. 3 may be directed to approach respondent No. 1 on 3rd of February, 2014 at 11.00 PM in her office, so that the matter can be amicably settled.

List for further consideration on 06.02.2014.”

Brief facts of the case are that vide order dated 23.04.2013, petitioner Smt. Nirmala Devi, Principal, GGSSS-Sampla, District Rohtak was transferred to GSSS, Nathupur vice Shri Jai Bhagwan – Respondent No. 3 in the aforesaid writ petition. Consequently, Shri Jai Bhagwan, Principal was adjusted at GGSSS, Ghamroj Alipur (Gurgaon) against a vacancy. It is pertinent to mention here that said Jai Bhagwan has been continuing at Nathupur since 23.01.2006. Subsequently, vide order dated 03.05.2013, the aforesaid orders were modified and Smt. Nirmala Devi was adjusted at GGSSS, Ghamroj Alipur (Gurgaon) in place of Shri Jai Bhagwan and Shri Jai Bhagwan was again adjusted at GSSS, Nathupur (Gurgaon).

Thereafter, Smt. Nirmala Devi filed the aforesaid writ petition dated 13.05.2013. Subsequently, vide order dated 08.07.2013, the orders dated 03.05.2013 were cancelled and accordingly, it was clarified that Smt. Nirmala Devi and Shri Jai Bhagwan will remain posted at GSSS, Nathupur and GGSSS, Ghamroj Alipur. However, the said orders dated 08.07.2013 were withdrawn vide order dated 08.08.2013, in view of the representation made by Shri Jai Bhagwan respondent No. 3. It is pertinent to mention here that Hon'ble Punjab & Haryana High Court vide interim order dated 12.08.2013 directed to maintain status quo, till the next date of hearing i.e. 02.09.2013. Consequently, on the said date 12.08.2013, Shri Jai Bhagwan has been continuing at GSSS, Nathupur (Gurgaon).

In view of Hon'ble Punjab & Haryana High Court orders dated 28.01.2014, as detailed above, both the petitioner as well as respondent no. 3 appeared before the undersigned on 03.02.2014 and statements of both of them have been recorded. Further, a list of vacant posts of Principal, Senior Secondary Schools in the entire district has been shown to both of them. However, these vacant stations are not acceptable to both of them and they have desired to keep them at Nathupur village or very near to them. Presently, there is no vacant post of Principal near Nathupur village.

I have gone through the contents of the file, Hon'ble Punjab & Haryana High Court order dated 28.01.2014, submissions made at the time of hearing and contents of statements of both, petitioner as well as respondent no. 3. It is specific to mention here that Smt. Nirmala Devi, Principal has violated blatantly the Government orders by neither joining in GGSSS, Ghamroj Alipur (Gurgaon) for about six months nor seeking any kind of leave during the said period, for reasons best known to her. Taking an overall view of the matter, Smt. Nirmala Devi, Principal is posted in GSSS, Gawal Pahari (Gurgaon), in view of the fact that the said station is just about 10 km from Nathupur village as well as her residence in Sector 54, Gurgaon. Accordingly, Smt. Pushpa Sharma, Principal, who has been posted in GSSS-Gawal Pahari (Gurgaon) since 06.12.2006 is transferred to GSSS, Nathupur (Gurgaon). Further, Shri Jai Bhagwan, Principal, GSSS, Nathupur (Gurgaon) is transferred to GSSS, Pataudi (Gurgaon) against vacancy. These orders shall take effect with immediate effect.

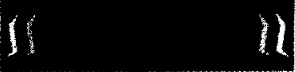

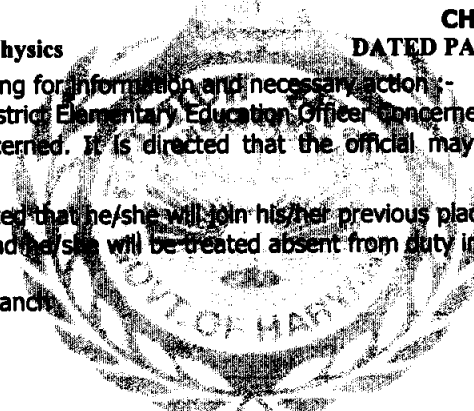
