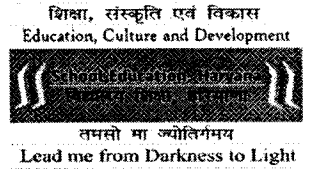



Whereas Sh. Ram Chander & others had filed a CWP No.4434 of 2013 in the Hon'ble High Court to grant the benefit of annual increment to the petitioners on the due dates after completion of one year as has been granted to the other employees in the light of judgement Annexure P-3(20.07.2013). The Hon'ble High court passed the following order on 28.02.2013:-

**“In the light of the facts noticed herein above. I deem it appropriate to dispose of the /present writ petition with a direction to respondent No. 2 i.e the Commissioner and Director General, School Education, Haryana, to consider the claim of the petitioner and decided legal notice dated 20-10-2012 (Annexure P-4) strictly in accordance with law and in the light of the Division Bench Judgement in Ramesh Kumar's case (Supra) and to take a final decision thereupon within a period of 4 months from the date of certified copy of this order”.**

In pursuance of judgement of dated 28.02.2013 in CWP No.4434/13 titled as Ram Chander & others V/s State of Haryana, the service book of two petitioner namely Sh. Sahib Singh, Retd. S.S Master, GSSS Prahladpur, Kurukshetra & Sh. Ashok Kumar, Science Maser GSSS Toda Panchkula have been persued. As per service of petitioner No. 16 i.e Sh. Sahib Singh, it had come to the knowledge that the petitioner was getting basic pay Rs. 7900/- on 31-12-2005 and he has been earns an annual increment of Rs. 200/-on 01-01-2006 and thereafter one annual increment has been granted on 01.07.2006 after completing six months services. Therefore there in no merit in the claim of the petitioner. His pay has already been rightly fixed.

In case of petitioner No. 17 i.e Sh. Ashok Kumar, he was granted annual increment in the month of February in pursuance of HCS Revised Pay Rules-2008, the pay of the petitioner was fixed at Rs. 13490+4600=18090 as on 01.01.2006 and was granted annual increment on 01.07.2006 instead of February 2006 i.e after 17 months of service after



Hon'ble D.B Bench judgement in CWP No. 16975/2010 Ramesh Kumar & others V/s State of Haryana. The finance Department Haryana issued instructions vide letter No. 6/84 /2010 TR (FD) dated 16.04.2012 and one increment was granted to petitioner Sh. Ashok Kumar in pre revised scale and his pay has been revised fixed Rs. 13820+4600=18420 in advertently. The petitioner is entitled to get pay Rs. 13810+4600=18410 per months (revised fixation of pay) after getting annual increment in the pre revised scale from 01.01.2006.

After due pursuance it is found that pay of petitioner No. 16 i.e Sh. Sahib Singh is rightly fixed and petitioner No. 17 i.e Ashok Kumar is wrongly fixed. Necessary action is being taken in this regard.

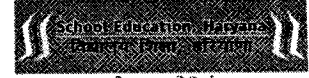
