Whereas Sh. Satyaveer Singh, J.B.T, R/o- Mohalla Naya Khatikan, Ward No.-9, M/Garh, The. & Distt. Mahendergarh [Govt. Primary School Kanti, M/Garh] & others had filed CWP No. 24653 of 2012 in the Hon'ble Punjab & Haryana High Court, Chandigarh and prayed for issuance of a writ in the nature of mandamus directing the respondents to grant the bunching increment to the petitioners as per revised pay of the petitioners under H.C.S. (R.P) Rules 2008 notified on 30.12.2008 No. GSR-Const./Art309/08 w.e.f. 1.1.2006, which has been granted to the similar situated employees in all over the state with all consequential benefits. The writ petition came for hearing before Hon'ble High Court on 12.12.2012 and the Hon'ble High Court pleased to pass the following order.

Without going into the merits of the case or commenting thereon, this petition is disposed of with directions to the Director, Secondary Education, Haryana-respondent No.2 and the Director, Primary Education, Haryana-respondent No.3 to Consider and decide the representation dated 08.11.2012 (Annexure P-2 within a period of four months from the date of receipt of certified copy of this order.

The decision, so taken, be conveyed to the petitioners forthwith. In case the petitioners are held entitled to the benefit as claimed by them through their representation, the consequential benefits be granted to them within a further period of two months. If the claim as projected by the petitioners is not to be accepted, then a speaking and well reasoned order be passed and the same be conveyed to the petitioners forthwith.

That in compliance of afore said directions of Hon'ble High Court, the contents of Annexure P-2 given by the petitioner was considered and record was summoned. After going through the record, it found that facts of the case are covered under Note 2 Rule 7 of HCS (RP) Rules 2008, which are reproduced below.

*

Every Government servant covered under the general ACP scheme shall, for the purposes of drawal of pay, be eligible for the first ACP grade pay (given in column 4 of Part II of Schedule I in respect of the functional pay scale or pay structure of his post) if he has completed 10 years of regular satisfactory service and has not got any financial upgradation in these ten years with reference to the functional pay structure of the post to which he was recruited as a direct entrant. Financial upgradation in this context includes functional promotion in the hierarchy or further revision/ modification of the pay structure for the same post after 01.01.2006.

It is clear from the Rules stated above that petitioner No 3 and 4 are not entitled to get the benefit of bunching increments on their pre revised scale as the same has been upgraded from 5500/9000 to 7450/11500. Moreover, the petitioners are working in master cadre grade, the multiple of magic factor i.e. 1.86 in more than minimum of pay band-2 i.e.9300-34800+4600 (GP). The case of the petitioners 3 & 4 do not cover under the preview of Rules and deserves to be rejected.

I pass an order accordingly.


