- No male teacher below the age of 50 years be allowed to join in the girls schools.





Present is an appeal against the order dated 14.01.2014 passed by Director Secondary Education (DSE), Haryana Panchkula, wherein a penalty of stoppage of one grade increment without cumulative effect is inflicted upon Shri Amarjeet Singh, Block Elementary Education Officer, Mundlana (Sonapat).


Brief facts of the case are that Shri Amarjeet Singh, Block Elementary Education Officer, Mundlana (Sonapat) was chargesheeted under Rule-8 of Haryana Civil Services (Punishment and Appeal) Rules, 1987 on the following charges:-

That inspite of imposition of ban regarding appointment of guest faculty, he appointed Smt. Suman, PGT Hindi and Smt. Rekha, PGT English on 14.05.2008 in GSSS Gohana (Sonapat) as guest teachers. In addition to this, he adjusted Smt. Sunita Rani as PGT Biology in GSSS Ramda (Sonapat), inspite of the imposition of ban.

After receipt of reply and personal hearing made in the matter, a penalty of stoppage of one grade increment without cumulative effect was inflicted upon him. Hence, this appeal. During hearing of the appeal, the said incumbent made written submissions and stated therein that the matter of drawing of the salary for the whole year in respect of guest teacher, who never attended the school, is not a matter of chargesheet. He further stated therein that he made complaint of then DEO Sonapat regarding pressurizing him to sign on bogus teaching experience certificate and he has sent emails and regd. Letters to the department also. He specifically mentioned that a compromise was arrived at in the presence of BEO Mundlana (Sonapat) and Chief Patron of Haryana Education Ministerial Staff Association, regarding complaint made against Smt. Suman Lata Arora, the then DEO Sonapat.

I have gone through the contents of the file, chargesheet, reply thereof, order dated 14.01.2014 passed by Director Secondary Education (DSE), Haryana Panchkula, written submissions made at the time of hearing of the appeal and documents submitted thereof and connected provisions of Haryana Civil Services (Punishment and Appeal) Rules, 1987. In this case, it is clear that during hearing of the appeal, it has not been denied even once that the appointments on guest faculty basis has been made, inspite of the ban imposed on 16.11.2007, as detailed in the chargesheet. Hence the said charge clearly stands proved against the incumbent. I have no hesitation to point out that penalty has not been inflicted in commensurate with the charges. However, without going into the procedure of recalling the impugned order, as provided in Rule 14(1) of Haryana Civil Services (Punishment and Appeal) Rules, 1987, appeal is dismissed, being devoid of merit.

I order accordingly.
