The factual matrix of the case are that an FIR No. 43, dated 25.01.2013 under Section 294, 354 and 506 IPC, PS-Sadar, Palwal was registered against Shri Dinesh Babu Upadhyay, Principal, GSSS, Bamni Khera(Palwal). Further, he was convicted by the court of Sh. Ved Parkash Sirohi, Addl. Sessions Judge (I), Special Judge (Protection of Children from Sexual Offences), Palwal vide order dated 14.08.2013 and sentenced as under:-

Offence under Section	Sentenced
294 IPC	Rigorous imprisonment for a period of three months alongwith fine of Rs. 1000/- and in default of payment of fine, to further undergo imprisonment for fifteen days.
354 IPC	Rigorous imprisonment for a period of two years alongwith fine of Rs. 5000/- and in default of payment of fine, to further undergo imprisonment for a period of two months.
506 IPC	Rigorous imprisonment for a period of one year alongwith fine of Rs. 2000/- and in default of payment of fine, to further undergo imprisonment for a period of one month.
Section 12 of the Protection of Children from Sexual Offences Act, 2012	Rigorous imprisonment for a period of three years alongwith fine of Rs. 5000/- and in default of payment of fine, to further undergo imprisonment for a period of two months.

Further, vide instructions No. 1449-5GSI-75/6324 dated 17/26.03.1975 issued by Chief Secretary to Govt. Haryana, the following tests should ordinarily be applied in judging whether a certain offence involves moral turpitude or not: -

- Shay*
- (a) Whether the act leading to a conviction was such as could shock the moral conscience of society in general.
 - (b) Whether the motive which led to the act was base one.
 - (c) Whether on account of the act having been committed the perpetrator could be considered to be of depraved character or a person who was to be looked down upon by the society.

It has been further conveyed vide said instructions that decision in each case will, however, depends upon the circumstances of the case and the competent authority has to exercise its discretion while taking a decision in


accordance with the above mentioned principle. Further, from the perusal of the list of offences which involve moral turpitude, enclosed with the said instructions, it is clear that all the offences committed by the incumbent fall in the category of moral turpitude.

As per instructions issued by Chief Secretary to Govt. of Punjab vide letter No. 4819-G II-57//11919 dated 08.07.1957, if a Government Servant is convicted of charges involving moral turpitude, he should be dismissed or removed from Government service and the filing of the appeal should not deter from inflicting a suitable punishment as provided in Proviso (b) to Sub Rules (2) of Rule 7 of the Haryana Civil Services (Punishment & Appeal) Rules, 1987.

After going through the instructions dated 26.03.1975 and 08.07.1957 as enunciated above, relevant provisions of the Haryana Civil Services (Punishment & Appeal) Rules, 1987, Judgment of Special Judge, Palwal dated 05.02.2011, it has been observed that a decision is required to be taken about dismissal or removal from service immediately on receipt of intimation of conviction in charges involving moral turpitude, without waiting for appeal or revision. The mere fact that an appeal has been filed by the Government servant against his conviction does not deter the punishing authority from inflicting a suitable punishment on him as provided in Proviso (b) to Sub Rules (2) of Rule 7 of the Haryana Civil Services (Punishment & Appeal) Rules, 1987. It is also not necessary in such cases to follow the procedure laid down in Rule 7 (1) of the Haryana Civil Services (Punishment & Appeal) Rules, 1987 regarding the holding of departmental enquiry. The Administrative Department is needed to examine whether the order passed should be one of dismissal or removal.

Taking an overall view of the matter and in pursuance of proviso (a) to Article 311(2) of Constitution of India read with Proviso (b) to Sub Rules (2) of Rule 7 of the Haryana Civil Services (Punishment & Appeal) Rules, 1987, Sh. Dinesh Babu Upadhyay, Principal (under suspension) GSSS Bamni Khera, Palwal is dismissed from service with immediate effect in the light of facts as enunciated above, especially in view of the fact that it is expected from the person of the stature of Principal to set high standards of moral character, integrity, probity and rectitude, which cannons have been completely violated by the said incumbent. It is specific to mention here that concurrence of HPSC is not required in inflicting penalty, as a consequence of conviction in criminal charges.

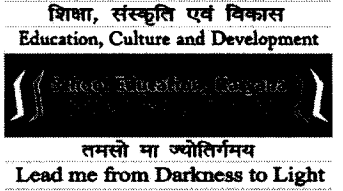

His pay will be fixed in the grade according to rules. He will also draw the usual allowances admissible to Government Servants of their categories from time to time.

His appointment in the School Education Department Haryana, will be on the following terms and conditions:-

1. His appointment is against purely temporary post, which is liable to be abolished at any time and carries no promise of subsequent permanent employment. As such, as and when there will be no vacancy against which he could continue to officiate in the School Education Department Haryana, he will be sent to his parent Department. It is, thus made clear to him that at present he has been offered temporary post.
2. In case at any stage, while he remains in temporary in temporary capacity and desire to resign his post he will be required to give one month's notice or forfeit in lieu thereof his salary including allowances for one month or the period by which the notice falls short of one month. He will give such a notice also in case, it is proposed to terminate his services for the reason other than that mentioned in clause (1) above.
3. His seniority amongst PGT, School Cadre will be on the tail in the Education Department.

4. He will not undertake higher studies of any kind without prior permission of the competent authority. Consequently no leave of any kind will be granted for perusing the higher studies.
5. He will remain on probation for a period of two years from the date of joining in the Department. The period of probation can be extended in accordance with the existing rules on the subject. For assessing his performance during the period of probation his work and conduct will be taken into consideration. If his work and conduct during the probation is not found satisfactory, his services will be terminated forthwith without assigning any reason.
6. No TA/DA or joining time will be paid to him for joining this post.

If he is willing to accept the offer made on the above mentioned conditions, he may get himself be relieved and report for duty to the Education, Department Haryana, Principal Govt. Sr. Sec. School Jind within a period of 15 days from the issue of this letter.




