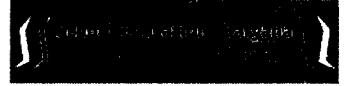

### Terms and Conditions:-

1. Their appointment is on a purely temporary post, which is liable to be abolished at any time and carries no promise of subsequent permanent employment. No offer of a permanent vacancy can be made to them at present in this respect.

2. This appointment is against temporary posts and their confirmation against substantive post shall be considered on the basis of their seniority and record of service as and when such post is available.
3. Their appointment is made on available Group 'C' temporary posts separately earmarked for staff transferred from Industrial Training and Vocational Education Department Haryana.
4. Their character and antecedents are to be verified in terms of Govt. instructions issued vide Memo No. 52/3/2005-6S(I) dated 18.11.2005, within 8 weeks from the date of issue of this order. It is made clear to them that in case, subsequently any adverse facts comes to the notice of the department regarding their character and antecedents, their services are liable to be terminated immediately without any notice and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificates/information.
5. Before assuming the charge of duty they will be required to take the prescribed oath of allegiance to the Constitution of India.
6. In case they are married, they will have to furnish a declaration to the effect that he/she is not having more than one living spouse. If he/she has more than one living spouse, he/she shall be eligible for appointment to the post offered only after the Government is satisfied that he/she has special ground for doing so, and exempt him/her from this condition. In case he/she is unmarried, he/she will have to furnish a declaration to the effect that he/she will not have more than one living spouse.
7. They shall not be allowed to apply for any post outside the department for a period of at least five years.
8. They shall not claim seniority on the basis of this order. Their inter-se seniority will also be decided in accordance with the relevant service rules and instructions of the State Government issued from time to time in this regard.
9. In the matters, not specifically mentioned in this communication, their services shall be governed by the Civil Services Rules as applicable to Haryana Government Employees and such orders/ instructions as may be issued by the Government from time to time.
10. In case of reserved category candidates, the appointment is provisional and is subject to verification of the Scheduled Castes/ Scheduled tribes/ Backward Class and ESM Category Certificate. If after verification it is revealed that the claim of the candidate belonging to SC/ST/BC and ESM category (as the case may be), is false then his/her services will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
11. They are hereby directed to produce their original certificates of academic qualifications, and other relevant certificates to the Head of Institution

concerned where they have been posted alongwith Photostat self-attested copies. The Head of Institutions will compare the Photo copies with the original and thereafter original certificates and testimonials will be returned to the candidates.

12. They should submit the Medical fitness certificate issued by the Chief Medical Officer concerned to the Head of Institution where they have been posted before joining their duties pursuant to this order. The District Education Officers concerned will also give character and antecedent verification forms to them and after filling up the form, they should submit the same to the District Education Officer concerned immediately.
13. If at any later stage it is found that he/she has got appointment on the basis of his/her furnishing false/forged documents or fraudulent information/ facts, he/she would be liable for termination of services without any notice.
14. If at any stage he/she desire to resign, he/she will be required to give one month's notice or forfeit in lieu thereof his/her salary including allowances for one month or for the period by which the notice falls short of one month. Such a notice will also be given to him/her by the competent authority in case it is proposed to terminate his/her services except as result of disciplinary action or for the other than that mentioned in clause-1 above.
15. They like the other Vocational Education staff transferred from Industrial Training & Vocational Education Department, to the School Education Department will continue to remain in separate cadres distinct from cadres of School Education Department even in case of similar subjects/duties.
16. The terms and conditions of the Govt. order No. 1/31-2005-Sec Edu./ Co (1) dated 24.2.2009 will be applicable.
17. They will not undertake higher studies of any kind without prior permission of the competent authority. Consequently no leave of any kind will be granted to pursue higher studies.
18. They shall be on probation for a period of two years from the date of joining in the Department. The period of probation can be extended in accordance with the existing rules on the subject. For assessing their performance during the period of probation their work and conduct will be taken into consideration. If their work and conduct during the probation period is not found satisfactory their services will be terminated without assigning any reason.
19. This offer of appointment is further subject to the 'Haryana Industrial Training and Vocational Education Department, Field Offices (Group C) Service Rules, 1998' and all other rules and regulations and executive instructions issued from time to time issued by the State Govt./Department. The rules on similar lines will be adopted by the School Education Department after requisite modifications.
20. If they have not been vaccinated within the last twelve months, they should have it done immediately.

21. If they are willing to accept this offer of appointment on the above terms and conditions, they should submit their joining reports to the Heads of Institutions concerned as per aforesaid directions.
22. They shall be covered under the New Pension Scheme-2009 of the Haryana Govt.
23. They are directed to join their place of posting within 15 days from the date of issuance of this order, failing which this offer of appointment will stand cancelled.
24. No TA/DA will be admissible to them for joining the post.
