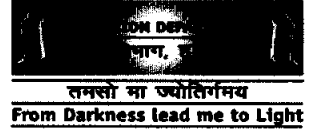





Whereas Sh. Surender Singh Chauhan had filed the CWP No. 7318 of 2012 for quashing the orders dated 20.01.2012 and 20.03.2012 (Annexures P-9 and P-10), vide which, on the basis of seniority list finalized by the order dated 10.02.2011, persons junior to the petitioner have been considered for regular promotion to the post of Block Education Officer, ignoring the rightful claim of the petitioner and further, prayed to consider the candidature of the petitioner for regular promotion to the post of Block Education Officer in view of the seniority position assigned to him on 01.06.2005 with all consequential benefits including seniority, arrears of pay etc.

The said writ petition, came up for hearing before the Hon'ble court on 23.04.2012 and the same was disposed of with the following directions:-

"Without going into the merits of the case or commenting thereon, the present writ petition is dismissed as withdrawn. In case the representation, as stated by the counsel for the petitioner, is filed by the petitioner within a period of one week from today to the Director Secondary Education, Haryana-respondent No. 3, the same shall be considered and decided by passing a speaking order within a period of two months. In case the claim of the petitioner is accepted, the consequential benefits, if any, be granted/released to him, in accordance with law, within a further period of one month.

Copy of the order be given dasti to the counsel for the petitioner under signatures of the Special Secretary to this court."


 As per the Hon'ble court directions, the representation of the petitioner was considered and it has been observed that the petitioner earlier had also filed CWP No. 16598 of 1998 in the Hon'ble Punjab & Haryana High Court on the same issue which was decided by the Hon'ble Court on 23.10.2006 in term of CWP No. 1205 of 2006 titled as Kavita Gupta Vs. State of Haryana which is still pending before the Hon'ble High Court and admitted on 23.10.2006.

During the pendency of the CWP No. 1205 of 2006 in the Hon'ble High Court, the petitioner cannot claim promotion as Block Education Officer on the basis of Kavita Gupta's case because the said matter has not attained finality, as yet.

It is further necessary to mention here that earlier the seniority of the petitioner was fixed by taking into account his ad-hoc service, later on the petitioner's seniority was rectified in the year 2011 from the date of his regular appointment and on the basis of that seniority list, he is not entitled for promotion, being junior. Moreover, Hon'ble Apex Court in Vijay Singh's case has held that adhoc period of service cannot be counted towards seniority.

In the light of above, representation of petitioner dated 25.04.2012 is rejected, being devoid of merit.

I order accordingly.

Whereas Sh. Bahadur Singh & others had filed CWP No. 7462 of 2013 praying therein to consider the claim of the petitioners for promotion to the post of Principal from the date, juniors to them have been promoted with all consequential benefits.

The Hon'ble High Court has disposed of the above CWP No. 08.04.2013 with the following orders:-

In the light of the facts noticed hereinabove, I deem it appropriated to dispose of the present writ petition with a direction to respondent no. 1 to consider the claim of the petitioners and to take a final decision of the legal notice dated 02.03.2013 (Annexure P-6) strictly in accordance with law and by passing a speaking order within a period of four months from the date of receipt of a certified copy of this order.


That in compliance of the Hon'ble Court direction dated 08.04.2013, legal notice of the petitioners was considered and found that all the petitioners were promoted as Headmasters of High Schools w.e.f 11.12.2012 in view of the Hon'ble Supreme Court order dated 23.09.2011 in various SLP(c) titled as Bhanwar Singh and others versus Bahadur Singh and others, filed against the order dated 03.03.2008 in CWP No. 16674 of 2006 titled as Bahadur Singh and another Versus State of Haryana and others. Subsequently it has been observed that all the petitioners were promoted as Headmasters inadvertently, because they were juniors to others similarly situated employees in their cadre of Sanskrit Teachers. Consequently, they were reverted back to the post held by them at the time of promotion as Headmaster, High School vide this office order no. 4/5-2013 HRG-II(1), dated 23.07.2013. The petitioners challenged their reversion orders by filing CWP No. 16248 of 2013, wherein the Hon'ble High Court has passed the following order on 29.07.2013:-

"In the meantime, the operation of the impugned orders Annexures P-9 to P-25 shall remain stayed."

Since earlier promotion of the petitioners to the post of Headmaster High School, as enunciated above, is in dispute, they cannot be considered for further promotion to the post of Principal, as a basic tenet of service jurisprudence, till the final decision of CWP No. 16248 of 2013 in the matter.

Keeping in view the peculiar facts and circumstances of the case, the claim of the petitioners is hereby rejected at this stage.

I order accordingly.
