Sanction is hereby accorded to the grant of sum of **Rs. 2,25,000/- (Two Lac Twenty Five Thousand Rupees only)** as Medical Advance to **Sh. Mohan Lal Clerk, GGSSS Siwan, Kaithal** to meet the expenditure in connection with **himself** treatment in **Fortis Hospital, Mohali** in relaxation to Pb./ Haryana Service Medical Attendants Rule, 1940 subject to the following:-

- 1- The Govt. will bear the expenditure spent on indoor treatment or Medicines/ Hospital charges only.
- 2- The amount of Medical Advance will be adjusted according to the Medical rules.
- 3- The Advance payment should not be considered that the Medical bill has been granted. It will be seen examining the case whether the amount will be adjusted or it is to be recovered.
- 4- The adhoc employee/officer will not be given Medical advance if an official employee is a temporary then he will have to give surety of a permanent officer/ employee, a retired officer / official will required to furnish surety of two permanent officers/ officials for getting the Medical Advance.
- 5- The payment of Medical Advance shall be made 15 days before the date of treatment.
- 6- Advance is allowed subject to the condition that the admissible bill amount will not be less than the advance amount.
