जिला शिक्षा अधिकारी, भिवानी द्वारा भी सूचित किया गया है कि विद्यालय दसवी कक्षा तक स्थाई मान्यता प्राप्त है। खण्ड शिक्षा अधिकारी, चरखी दादरी की जांच उपरान्त तथ्य सामने आए हैं कि विद्यालय में कक्षाएँ नहीं चल रही हैं और विद्यालय की मान्यता तुरन्त प्रभाव से रद्द करने की सिफारिश की गई है। हरियाणा विद्यालय शिक्षा नियम 2003 के अनुबन्ध 43 में (ग) में स्पष्ट उल्लेख है कि :-




