Disciplinary matter of Sh. Ram, Chander Dahiya, Deputy Director(Retd.) was decided vide order No. 12/22-2010-Admn.(2) dated 15.11.2013 and a penalty of cut in pension to the tune of 50% for whole life was inflicted upon him as provided in Rule 2.2(b) of Punjab Civil Services Volume II, as applicable to Haryana, by seeking prior approval of Haryana Public Service Commission. For deciding the suspension period from 27.05.2005 to 30.11.2007, a show cause notice was issued vide Memo No. 12/22-2010-Admn.(2) dated 10.02.2014 on the following grounds: -

1. Why the pay and allowances for the suspension period be not restricted to whatever have been paid during the suspension period?
2. Why the suspension period be not treated as non-duty period?

In consequence thereof, he made representation dated 06.03.2014/10.03.2014, wherein he again elaborated the submissions made, while making representation and at the time of personal hearing in the disciplinary matter. He was again heard on 28.05.2014, wherein also he reiterated the earlier submissions made in the matter. It is specific to mention here that the incumbent has since retired and decision about the pay and allowances and treating the period of suspension as duty period or not is governed by Rule 7.3 of The Punjab Civil Services Rules Volume I Part I, as applicable to Haryana. Further, instructions issued by Chief Secretary to Govt. of Punjab vide letter No. 6613-GI-58/20259 dated 07.07.1958 have to be kept in view in cases where the charge(s) have been proved against the employee concerned. From the perusal of the reply to the show cause notice dated 10.02.2014 and submissions made at the time of personal hearing dated

28.05.2014, it is clear that the incumbent has not requested to treat the period of suspension/absence from duty as leave of any kind due and admissible to the Government Employee. Hence, the said aspect has not been considered in view of proviso to Rule 7.3(5) of The Punjab Civil Services Rules Volume I Part I, as applicable to Haryana.

After going through the reply of show cause notice dated 06.03.2014/10.03.2014, written submissions made at the time of personal hearing dated 28.05.2014 and document annexed therewith, relevant provisions of The Punjab Civil Services Rules Volume I Part I and Government instructions issued from time to time in this regards, it is clear that huge purchases to the tune of approximately Rs. 2 crore have been made by the incumbent in connivance with Block Education Officers concerned in violation of canons of financial propriety, financial rules and instructions issued by Haryana School Shiksha Pariyojana Parishad blatantly and as a consequence thereof, a penalty of 50% cut in pension for whole life has been inflicted upon him, as detailed above.

In the light of above, period of suspension/absence from 27.05.2005 to 30.11.2007 shall be treated as non-duty period for all intents and purposes including treating the same as non-qualifying service for retiral benefits. Further, he shall not be paid more than whatever has already paid to him during the said suspension period.
