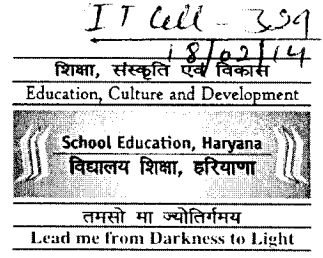



**ORDER No. 10/20-2008 HRG-I (2)**

**Dated, Chandigarh, the 10/2/2014**

Whereas, Sh. Maman Singh, Retired District Elementary Education Officer, Sonapat was charge sheeted under Rule 7 of Haryana Civil Services (Punishment and Appeal) Rules, 1987 vide order No. 10/20-2008 HRG-1(2)/1870 dated 23.04.2009 and the following charges were levelled against him.

1. That Sh. Maman Singh purchased gas stoves with lighter, pipe, regulator and burner @ Rs. 1310/- per unit from Faridabad Central Cooperative Consumers Store Ltd., Faridabad which was not an approved source for the purchase of the said articles.
2. That the market price of the set of articles was about Rs.710/- but he paid for the said set @ Rs.1310/- per set plus VAT charges and thus caused a financial loss of Rs. 2,76,600/- to the State Government.

He replied to the said charge sheet on 04.05.2009. Finding his reply as unsatisfactory, Sh. O.P. Gupta (Retd.), District and Session Judge was appointed as regular Inquiry Officer vide order dated 29.09.2009. The Inquiry Officer, **concluded the enquiry with this observation that the evidence against the charged officer are not sufficient to prove his guilt.** Thereafter, a committee, presided over by the Additional Director Admn., Technology Officer and XEN O/o Director Secondary Education, Haryana were other members was constituted to find out the optimum price of the gas chullah/bhatti. The committee vide their report dated 02.05.2012 concluded that the cost of the said item in the year of purchase, i.e. 2007, was Rs.686.25. In compliance of Rule 7(6) of Haryana Civil Services (Punishment and Appeal) Rules 1987, while disagreeing with the inquiry report, a dissenting note, primarily on the ground of purchasing the items from an unapproved source, non-ISI mark and at higher rate of Rs.1310/- instead of optimum price of Rs.710/-, along with a copy of the inquiry report was sent to the said incumbent to make a written representation within a period of one month, if he so desired, vide letter dated 11.07.2012/27.08.2012. In response to the said, he submitted his reply on 22.09.2012, and mainly contended that the charges levelled against him are incorrect that Faridabad Central Cooperative Consumer Store Ltd., Faridabad was not an approved source, in view of the Supplies and Disposal Department letter dated 30.01.2008, whereas actual purchases were made in  November, 2007. Further, stated that there is no malafide intention on his part and he spent an entire amount of Rs. 23,05,000/- instead of Rs. 6,28,066/-.

After going through the contents of the charge sheet, reply thereof, report of regular inquiry officer, dissenting note and written representation in consequence thereof, finding on the charges is as under:-

1. Regarding charge No.1, it is clear that it was incumbent upon the part of the officer to have verified from the department as well as Supplies and Disposal Department about the approved source of purchase of said item and also whether Faridabad Central Cooperative Consumer Store Ltd. was an

approved source, which has not been done in this case. Hence, the charge clearly stands proved.

2. Regarding charge No. 2, again it is clear that the item purchased was not of ISI mark. Further, the incumbent has failed to verify the rate of the item in the open market. Had the same been done by him, the truth would have come. Thus, he has violated the canons of financial propriety and purchased the said items at exorbitant rates of Rs.1310/-, instead of maximum prevalent price of Rs.710/- during the said period. Hence, the charge clearly stands proved. In this way, total value of 461 gas chullahs/bhattis comes out to the tune of Rs. 3,35,608/- (including 4% VAT), whereas payment to the tune of Rs. 6,28,066/- has been made, resulting in causing a loss of Rs. 2,92,498/- to the state exchequer.

Taking an overall view of the matter as enunciated above, it would be appropriate that the following penalties may be inflicted upon Sh. Maman Singh, HES-I (Retd.):-

1. Recovery of loss of Rs.2, 92,458/- from the retiral benefits.
2. Cut in pension to the tune of 2% for whole life under Rule 2.2 (b) of Punjab Civil Services Rules, Volume II, as applicable to Haryana. This order is being issued after approval of Haryana Public Service Commission.
