Note :-

- The official will be relieved immediately and in any case within 3 days falling which he/she will be liable for disciplinary action, However if any official is working in Census duty, he/she shall not be relieved till the Census duty is accomplished.
- No TA/DA and joining time will be admissible to the official if he/she has been shifted on his/her request after exercising option.
- No male teacher below the age of 50 years be allowed to join in the girls schools.
- If there is no vacancy in the destination school for any reason the incumbent transferred shall re-join his/her previous place of posting and also inform to concerned branch/computer cell at HQ.
If any discrepancy is noticed in this order or there is a violation of transfer policy, It should be brought to the notice of Computer Cell/Concerned branch within three days and the order be not implemented.
- In case of mutual transfer, it is directed that before relieving/joining the officials concerned, it may be ensured that the distance between both the schools is not less than 8 km.
- In case of urban area stations while implementing the transfer orders, it may be ensured that the transferee has completed the rural service as per transfer policy.
- The mutual transfer would be effective only when both the employees seeking mutual transfer submit a consent document to their respective Principals.

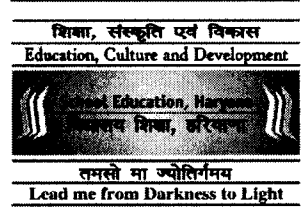

Terms and Conditions

1. On the availability of the unavailable ACRs of previous years as mentioned above, if the integrity of the promotee is found doubtful he will be reverted without giving any notice.
2. The inter-se-seniority of the promotee is subjected to the claim of his seniors, who have not been promoted in these order due to various reasons and for whom the posts are kept reserved.
3. If an official is found senior to these officials at any stage due to re-fixation of his seniority in his feeder cadre, the junior most promotee shall be reverted without giving any notice.
4. If at any stage it is found that any official has been promoted in these orders inadvertently who was otherwise actually not eligible for promotion will be reverted to his feeder cadre original post without any notice.
5. That this promotion is subject to the condition that all the particulars and data supplied by the concerned employees and field offices are correct. In the event of any information found to be factually incorrect, erroneous or misrepresented, the promotion so granted shall be withdrawn forthwith without affording any further opportunity.

6. The promotion is subject to the decision of the Hon'ble High Court in CWP No.5592/1992-Sh. S.S. Sethi Vs. State, CWP No.3633/94 - Ravinder Sethi Vs. State, CWP No.4857/99- Sh. Attar Singh and others Vs State and CWP No. 9746/2001- Sher Singh and others Vs State of Haryana & others and other similar writ petitions.
7. If the seniority of any official is fixed later on according to the instructions contained in Govt. letter No.22/73/92-3GS-III dated 14.10.99, he/she will be reverted without giving any notice.
8. That the Lecturer who are on deputation with Chandigarh Administration or on Foreign Service and his/her junior is given promotion, he/she will be entitled for proforma promotion under next below rules.
9. Incumbents promoted from amongst Lecturers shall have to undergo atleast three weeks in service training in administrative and accounts module.

Promote is directed to join his new place of posting and submit his joining report direct to the undersigned/ Director Secondary Education, Haryana, Panchkula within seven days otherwise their promotions will be treated as cancelled without any further notice. It shall be assumed that since he has not joined, he is not interested in promotion and the next incumbent will be considered for promotion.
