5. The salary will be paid as per provisions of CSR Vol-II i.e. last pay drawn minus pension.



**Order No. 11/2-2014 HR C&V (1) Dated Panchkula the, 13.03.2014**

Whereas Sh. Chitwant Singh was appointed by the District Level Committee, Kurukshetra as Hindi Teacher in 1997 on contract. Accordingly, he joined on 02.12.1997. thereafter, he was relieved due to joining of Regular Appointee. After relieving he could not be adjusted and Sh. Chitwant Singh had filed a CWP No. 13562 of 2003 titled as Chitwant Singh Vs. State of Haryana & Another praying in issue a writ in the nature of Mandamus, directing the respondents to reinstate the petitioner in service on the post of Hindi Teacher with consequential benefits arising thereof including continuity of service by holding his relieving illegal, and further direction be issued to allow the petitioner to continue in service till regular appointment is made on his post in accordance with law.

When the matter came up for hearing on 28.08.2003 before the Hon'ble High Court. The Hon'ble Court pleased to pass the order and the operative part of order is reproduced as under:-

**" After hearing the learned counsel for the petitioner at same length and keeping in view the facts and circumstances of this case, we dispose of the writ petition with a direction to the respondents to decide representation. Annexure P-3 of the petitioner and passed speaking order on the same within a period of four months from the date a certified copy of this order is brought to their notice.**

The Writ petition stands disposed of accordingly."

In compliance of above said orders, the matter was examined and Sh. Chitwant Singh was allowed to join on contract basis as Hindi Teacher. Accordingly, he joined on 14.01.2004 in Govt. High School, Gudda, Distt. Kurukshetra.

Sh. Chitwant Singh has submitted a representation for condoning the period i.e. 22.05.1998 to 13.01.2004. It is pertinent to mention here that he has attached copy of orders by which such type of periods has already been condoned in identical facts.


