In pursuance to the order dated 23.01.2014 passed in CWP No. 13431 of 2008 by the Hon'ble Punjab and Haryana High Court, the Governor of Haryana is pleased to appoint Sh. Dharampal Dahiya S/o Sh. Raghbir Singh, H.No. 992, Sec-23, HUDA, Sonipat (Haryana) as Principal in Government Senior Secondary School, in the pay scale of Rs. 15600-39100 plus grade pay 6000/- plus usual allowances as admissible under the State Government Rules from time to time. He is directed to join his place of posting mention against his name within 15 days from the date of receipt of this order on the following terms and conditions :-

Terms and Conditions :-


1. He is appointed purely on temporary and provisional basis.
2. This appointment is against temporary post and his confirmation against substantive post shall be considered on the basis of his seniority and record of service as and when such post is available.
3. He shall have to take an oath of allegiance to the Constitution of India.
4. He shall produce a certificate before joining the duties to the effect that he has one living wife in case he is married. None of them who has more than one living wife, shall be eligible for appointment to the post offered unless the Government after being satisfied that there are special grounds for doing so, exempt him from this condition.
5. The person is entitled for notional benefits for the purpose of seniority and pay fixation as Principal with immediate effect. His inter-se seniority will also be decided in accordance with the department rules and instructions of the State Government (Merit No. 301-A) is entitled with immediate effect.
6. He shall be on probation for a period of two years, the period of probation can be extended for a further period not exceeding one year, if considered necessary.
7. In other matters, not specifically mentioned in this communication, he shall be governed by the Civil Services Rules as applicable to Haryana Government Employees and such orders/instructions as may be issued by the Government from time to time.

8. In case of reserved category candidate, the appointment is provisional and is subject to the ESM/Scheduled Castes/Schedules tribes and Backward Class Certificate being verified through the proper channels. If the verification reveals that the claim of belonging to ESM/ SC/ST and BC, as the case may be is false, then his services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
9. **It is made clear that character and antecedents have not been got verified before issue of the appointment letters to the appointee and in case subsequently any adverse fact comes to the notice of the State Government/Department regarding his character and antecedents, his services shall be terminated without any notice.**
10. He has been selected as Principal is hereby directed to show their original documents of academic qualification and other relevant certificate to the concerned District Education Officer of his place of posting. District Education Officer would verify the genuineness of his original certificates. District Education Officer will ensure that the candidate submit his medical fitness certificate first duly issued by the Medical Board only then he should join as Principal in respective school of posting. District Education Officer will also give character and antecedents verification form to him and after getting him filed in by him, the same be sent to the Directorate through a special messenger within a week's time. This is the personal responsibility of the concerned District Education Officer.
11. If he is already in Govt. job as class-II officer need not to submit a fresh medical fitness report.
12. His service shall be governed by the Haryana State Education (School and Inspection Cadre) (Group-B) Service Rules, 1998 duly amended in 2001 for the post of Principal.
13. If at any time during the course of his temporary appointment, he desires to resign, he shall be required to give one month's clear notice or forfeit, in lieu thereof, his salary including allowances etc. for one month or for the period by which the notice falls short of one month. Such a notice will be given to him by the Government also in the case, if is proposed to terminate his services in lieu thereof the Government will be liable to pay his salary, including allowances for one month or for the period by which the notice falls short of one month.
14. No TA/DA will be admissible to the candidate for joining as Principal.

15. If he gets an appointment as Principal on the basis of furnishing false of fraudulent information/facts which are detected later on, he would be liable for termination of service without any notice.
16. His appointment is further subject to the final outcome of decision of Government in the case of Sh. Bijender Singh, Roll No. 3616 in ESM category who has already been served with a show cause notice that why his services may not be dispense with being junior most in ESM category as declared by HSSC.

If he is willing to accept this offer of appointment as Principal, HES-II (School Cadre) on the above terms and conditions, he should submit his proof of academic qualifications, experience and other relevant certificates to the Directorate in original as per aforesaid directions.

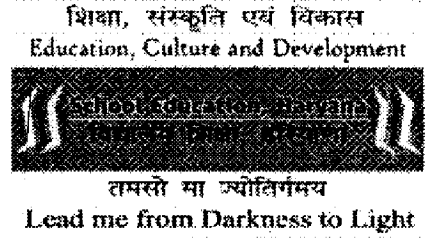
