

Governor of Haryana is pleased to accord Administrative sanction to grant Drawing and Disbursing Powers to Elementary School Head Masters of independent middle schools to draw pay, allowances and arrears in respect of teaching and non-teaching staff of their respective schools and also the grants of various schemes of the School Education Department, provided by the Government under various plan/ non-plan budget heads.

Further, in case of composite schools i.e. schools upto Classes X & XII, Head Masters of Govt. High Schools and Principals of Govt. Senior Secondary Schools, as the case may be, shall be the sole DDOs for their respective schools. The funds relating to various schemes in respect of Elementary wing of High/Senior Secondary Schools will, however, be placed at the disposal of the Elementary School Head Masters, so that the same is spent for the specific purpose, under the overall supervision of Head Master/Principal concerned. Similarly, Elementary School Headmasters after drawing amount of grant in respect of primary wings of their school(s) or of primary schools under their administrative control shall provide it to the primary school head teacher concerned.

This issues with the concurrence of Finance Department as conveyed vide U.O. No. 22977-4FD-II/2013, dated 05.09.2013.
