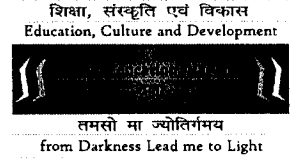

**ORDER**

The Secretary, Haryana Staff Selection Commission, Panchkula sent communication dated 28.09.2015 alongwith recommendation list of 54 candidates for appointment of Lecturer Hindi (School Cadre) against Advt. No. 6/2006 Category No. 6. The department after examining, issued appointment orders to 44 candidates vide order No. 6/15-2015 HRL (4)/ Hindi dated 26.11.2015. Further, in view of communication dated 24.11.2015 of the Secretary, Haryana Staff Selection Commission, Panchkula intimated to keep seven posts who are lower in merit in the recommendation list dated 28.09.2015 for the post of Lecturer Hindi (School Cadre) belonging to General category may be kept unfilled.

In view of above letter candidates at Sr. No. 23, 24, 26 to 30 were withheld. Now the Commission clarified vide letter dated 02.12.2015 to keep the seven posts unfilled of General category i.e. Merit No. 27 to 33. The department already withheld the appointment of Merit No. 27, 28, 29 and 30 which were lower in merit. Further the appointment letter issued to the candidates Merit No. 31, 32 and 33 which are of Reserve category but selected against General category are hereby withdrawn as the appointment letters were issued inadvertently since the candidate Merit No. 27 to 33 were lower in merit. The appointment accordingly given to the candidates who are at Merit No. 23, 24 and 26, which were withheld earlier vide letter dated 11.12.2015. The appointment letters issued vide order dated 26.11.2015 in respect of the following candidates are hereby withdrawn :-
