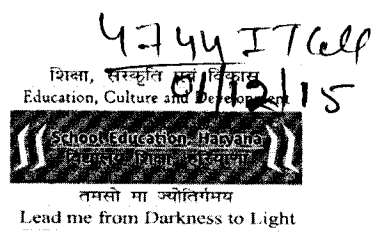

Whereas, Sh. Dharampal Sharma, PGT English, GSSS, Ballah (Karnal), now retired was charge sheeted under Rule-8 of Punishment & Appeals rules, 1987 vide Order No. 16/52-2012/2674 HRL(2), dated 18.06.2012 wherein the following charges were levelled against him:-

It is established from the above facts that there is certain laxity and dereliction of duty on part of Sh. Dharampal Sharma while engaging Sh. Sushil Kumar as guest Hindi Teacher. Being Head of the Institution, it was required on his part to know about the departmental instructions and service rules before appointing Sh. Sushil Kumar as guest teacher. Being head of the selection committee, it was further required on his part to check and verify all the facts before selecting the candidates, but he miserably failed to do so and appointed the candidate as Hindi Teacher even who did not have requisite qualifications with him at the time of his engagement. It clearly shows that there is gross negligency on part of Sh. Dharampal Sharma.

Keeping in view the above facts, it is established beyond doubt that Sh. Dharampal Sharma has caused loss to the Government by appointing ineligible person against sanctioned post, thus, I, ordered to impose a penalty of Rs. 10,000/- recoverable from the pension of the petitioner in 10 equal installments under Rule 2.2, Note 1(B) (1) read with Note 3 (B) (1) of the CSR.

It is established from the above facts that there is certain laxity and dereliction of duty on part of Sh. Prayag Raj while engaging Kusum & Vandana as guest Teacher. Being Head of the Institution, it was required on his part to know about the departmental instructions and service rules before appointing Kusum & Vandana as guest teacher. Being head of the selection committee, it was further required on his part to check and verify all the facts before selecting the candidates, but he miserably failed to do so and appointed the candidates as Guest Teacher even who did not have requisite qualifications with them at the time of their engagement.
