ORDER**

Whereas, Hon'ble Punjab and Haryana High Court in CWP No. 16975 of 2014 titled as Balwinderjit & Others Versus State of Haryana and another, vide its order dated 21.08.2014 has directed as under:-

“In the light of submissions made by the counsel for the petitioners and without going into the merits of the case or commenting thereon, the present petition is disposed of with directions to the Financial Commissioner and Principal Secretary to Government of Haryana, Department of Education, Haryana respondent No.1 to consider and decide the legal notice dated 01.06.2013 (Annexure P-11) served by the petitioners within a period of two months' from the date of receipt of certified copy of this order.

In case the claim of the petitioners is accepted, the consequential benefits, if any, be released to them, in accordance with law, within a period of one month. In case the claim of the petitioners is not to be accepted, a well-reasoned and speaking order be passed and conveyed to them forthwith.”


Brief facts of the case are that in the year 1972, three installments of adhoc relief were granted to the petitioners alongwith other employees. Subsequently, while granting additional Dearness Allowance to Haryana Government Employees w.e.f. 01.05.1973, 01.09.1973, 01.10.1973 and 01.01.1974 vide letter no. 1699-3FR-74/10392, dated 20.03.1974 ranging from 3% to 16%, adhoc relief already granted in the year 1972 were adjusted, being excess amount to the tune ranging from Rs. 9.40/- to Rs. 45/-. Accordingly, Hon'ble Punjab and Haryana High Court in CWP No. 6567 of 1990, titled as Prem Chand and others Versus State of Haryana and others, decided on 10.10.1990, has directed not to adjust the said excess amount in view of judgment passed by Punjab and Haryana High Court in CWP No. 5563A of 1989 titled as Nitya Nand and others Versus State of Haryana and others decided on 23.04.1990. It is specific to mention here that Special Leave petition in the Nitya Nand's case was dismissed on 18.01.1991 and even the Curative petition (Civil) no. 9 of 2005 in Review Petition (Civil) No. 594-595 of 2003 was dismissed vide order dated 07.02.2011.

In a separate matter, in SLP No. 20144 of 1991 titled as State of Haryana and another Versus O.P. Sharma and others and various other SLP's, Hon'ble Apex Court vide its order dated 17.02.1993 has observed that Nitya Nand's case was based on college teachers case, whereas this case has no concern with the college teachers case and there was no question of any

adjustment of adhoc relief in the case of college teachers. Accordingly, the Special Leave Petitions filed by the employees against the order of High Court upholding the validity of Haryana Government order dated 20.03.1974, were dismissed. As a consequence of the same, instructions in the matter were issued by Finance Department Haryana in the matter vide letter no. 4/26/90-FR-II, dated 12.10.1998. These instructions were further reiterated by Finance Department, Haryana vide letter no. 4/26/90-1FR, dated 06.01.2004.

After going through the Hon'ble High Court order dated 20.08.2014, legal notice dated 01.06.2013 served by the petitioners, Hon'ble Apex court order dated 17.02.1993, Finance Department instructions dated 12.10.1998 and 06.01.2014 as enunciated above, it is evident that the order dated 20.03.1974, vide which excess adhoc relief granted in the year 1972 has been adjusted, is legally tenable covered by order dated 17.02.1993 in SLP No. 20144 of 1991 and various other SLP's, as detailed above. Hence, legal notice dated 01.06.2013 is rejected, being devoid of merit.

All Branch Superintendents/Officers and District Education Officers are hereby directed to ensure the compliance within three days and in future, no such proposal should be sent for approval.


