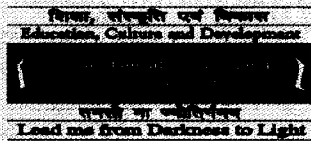

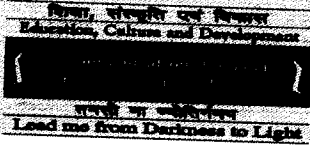

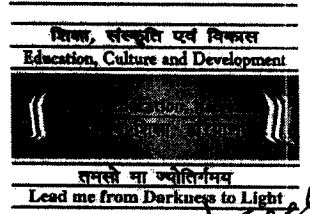

Smt. Mitalesh Yadav Principal [055556], GSSS Karterpuri (Gurgaon) [750] is hereby deputed at New Delhi Municipal Corporation (NDMC) as Deputy Education Officer in the pay scale of Rs. 15600-39100+ Grade Pay Rs. 6600 + usual allowances for a period of one year.

The deputation is subject to the following terms and conditions:-

1. The period of deputation should not ordinarily exceed one year at a time and should not normally be extended beyond 3 years. Where it is considered necessary in the public interest and in exceptional circumstances to extend the period of the deputation on Foreign Service prior approval of the Finance Department should always be obtained well in time, giving full justification in this regard.

Government has inherent powers to terminate deputation earlier than the period specified in the terms and conditions of deputation. The Government may, therefore, recall a Government employee, at any time before the expiry of the period of deputation, when the exigencies of public service so require. Similarly, the foreign employer can also make a recommendation to Government for the recall of the Government employee concerned. A specific clause to this effect may invariably be incorporated in all orders deputing Government employees to Foreign Service.

2. A Government employee who has served on deputation in a State or Central organization should not be allowed to proceed on deputation to some other foreign organization again unless he has worked for a minimum period of 2 years on a post in his parent department subsequent to his reversion.
3. A Government employee already on deputation/foreign service with some other Government should not be allowed to proceed on deputation/foreign service to another Government/body

direct from his first deputation/foreign service without the approval of the Finance Department.

4. No TA/DA and joining time will be given in this regard.
