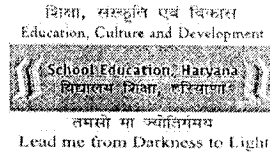



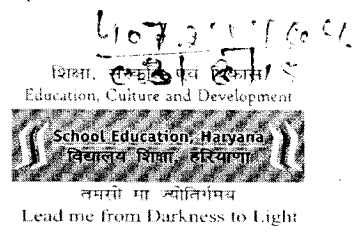

Whereas, Sh. Umed Singh, Principal had filed CWP No.12674 of 2015 in the Hon'ble Punjab & Haryana High Court, praying therein to quash his transfer order dated 17.06.2015, vide which he was transferred from Govt. Girls Sr. Sec. School, Agroha (Hisar) to Govt. Sr. Sec. School, Parbhuwala (Hisar) vice Smt. Renu Bala, Principal. This case came up for hearing before the Hon'ble High Court on 29.06.2015, wherein the following order was passed :-

“Without commenting anything on the merits of the case and keeping in view the limited prayer of the petitioner; the present petition is disposed of with a direction to respondent No. 3 to consider the representation dated 22.06.2015 filed by the petitioner and take necessary action in accordance with law.

The necessary exercise be done within a period of four weeks from the date of receipt of certified copy of this order.”

That in compliance of the aforesaid direction of the Hon'ble Court, the representation of the petitioner dated 22.06.2015 has been considered and it has been found that petitioner was posted as Principal at Govt. Girls Sr. Sec. School, Agroha (Hisar) but as per transfer policy of the State/Education Department, no male employee below the age of 50 years can be posted in a girl school. Since, the age of the petitioner is below 50 years, thus, the petitioner was transferred from Govt. Girls Sr. Sec. School, Agroha (Hisar) to Govt. Sr. Sec. School, Parbhuwala (Hisar) against Smt. Renu Bala, Principal.

Keeping in view the transfer policy and given circumstances of the case I have come to the conclusion that the earlier adjustment order of the petitioner on promotion at Govt. Girls Sr. Sec. School, Agroha (Hisar) was made inadvertantly, otherwise too, as per transfer policy, he could not have been adjusted in GGSSS, being below the age of 50 years. Consequently, the petitioner was transferred vide order dated 17.06.2015 from Govt. Girls Sr. Sec. School, Agroha (Hisar) to Govt. Sr. Sec. School, Parbhuwala (Hisar) vice Smt. Renu Bala, Principal. However, taking into consideration the fresh representation of the petitioner dated 16.07.2015, he is adjusted at G.S.S.S., Balsamand (Hisar).

I pass order accordingly.


