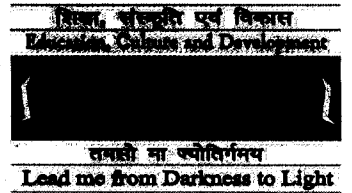

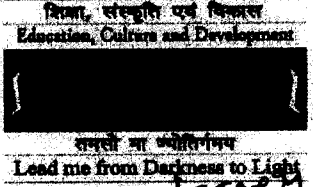

**ORDER**

In exercise of the powers conferred upon me under rule 34(1) of Haryana School Education, Rules, 2003, sanction is hereby accorded to grant permanent recognition to OPY World School, VIII. Bharaf (Mahendergarh) for class 9 to 12 (Arts, Commerce & Science) under BOSE pattern with effect from 01.04.2015 run by Managing Committee, Rao Mohar Singh Educational Society, 1664-D, Prem Nagar, Najafgarh, New Delhi. under the following terms and conditions:-

**TERMS & CONDITIONS:-**

1. This permanent Recognition is granted that on the subject to the condition that the documents/information furnished by the school authorities are factual and not devoid of truth in any way. however, if any information at any stage, is found contrary to the facts the recognition would be revoked forthwith.
2. The school shall follow the course of study as per syllabus prescribed by the affiliated board.
3. The school shall charge fees and funds as declared to the appropriate authority at the time of application for recognition and display the same on the notice board of the school and shall not increase the fees during the any academic session. In case of any change in the fee structure the school shall inform to the appropriate authority in the month of January for the next academic year and will also issue printed receipts of fees/funds to the students.
4. Salary shall be paid as per declaration at the time of seeking recognition.
5. No capitation fee and other charges shall be charged from the children/parents.
6. School shall be open for admission without any discrimination based on religion, caste, race, place of birth or any other whimsical.
7. Managing Committee shall not allow to run two schools affiliated by different board/council in same premises.
8. Managing Committee shall not close down the school or and existing class during the academic session without the prior approval of the appropriate authority.
9. The school shall be open for inspection for the inspecting officer authorized by the Director/Appropriate Authority.
10. Recognition so granted shall be reviewed after every 10 years.
11. No financial assistance shall be granted by the Department to the school.
12. School premises shall not be used for commercial purpose and anti National activities.
13. Approval of Managing Committee shall be obtained from the appropriate authority in case of any change in the committee.
14. The Managing Committee shall follow the instructions issued by Government/Director from time to time and supply the information to the Govt./Department as required.
15. In addition to above the Managing Committee shall abide by the provisions of Haryana School Education Rules, 2003 and amendments if any thereafter. The Managing Committee shall be liable for disciplinary action in case of violation of any provisions of the rules.
16. School will provide ramp within six months otherwise recognition will stands withdrawn.
17. If any information, at any stage found Contrary to the Facts the recognition would be revoked forthwith.
18. That the number of students in classroom shall not be more than the students calculated on the 10 square feet per student for secondary and Senior Secondary Schools and 9 Square feet per student fo elementary state.
19. The managing committee shall abide by the provisions of Haryana School Education Rules 2003(amended) & R.T.E. Rules 2011 and amnedments it any thereafter. The Managing shall be liable for diciplinary action in case of violation of any provision of the rules.

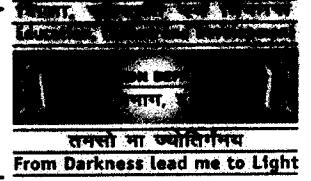

Sh. Ravi Kumar Headmaster, Government High School Dhani Hanuman (Bhiwani) was appointed as Headmaster vide order No. 4/29-2004 E-I (4) dated 14.10.2004 against Scheduled Caste quota posts. While applying for the post of Headmaster, he enclosed 8 years teaching experience certificate as Hindi Teacher from 10.08.1995 to 14.10.1997 of Maharishi Dayanand High School Bhiwani and from 15.10.1997 to 30.08.2003 of Bharat Sadan Shiksha High School Bhiwani with his application form. As a consequence of a complaint it came to the notice that his experience certificate is bogus and the same was got enquired from District Education Officer, Bhiwani. During investigation Maharishi Dayanand University, Rohtak informed vide letter No 16111 dated 20-11-2014 that Sh. Ravi Kumar S/o Sh. Dalip Singh was a regular student of M.A. Hindi in Vaish College, Bhiwani during session 1999-2000 and 2000-2001 and passed MA examination from Maharishi Dayanand University, Rohtak under Roll No 182099 in May, 2001. This period is completely covered in the period of experience as detailed above. Hence his experience as Hindi teacher is vague and bogus.

It is a statutory condition in every appointment in a public service that in the eventuality of appointment of bogus certificate, the same shall be terminated forthwith, After going through the facts and evidence on record, it has been established beyond doubt that Sh. Ravi Kumar got the job of Headmaster in the year 2004 on the basis of bogus and forged teaching experience certificate as Hindi Teacher.

As per terms and conditions of appointment letter, the appointment shall stand terminated without giving any notice. However, in the interest of justice, I deem it proper to give the incumbent an opportunity of showing cause against the action proposed to be taken. Any representation, which he may like to make in this regard, will be considered before the proposed action is taken. Such representation, if any, should be made in writing and submitted to the competent authority so as to reach not later than fifteen days from the receipt of this communication to him. In case of failure, it will be presumed that he has nothing to say in this regard and exparte order will be passed accordingly.

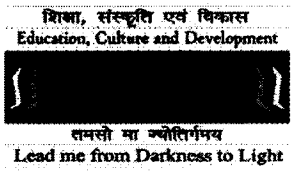
