1. 2. The school shall follow the course of study as per syllabus prescribed by the affiliated board.
3. The school shall charge fees and funds as declared to the appropriate authority at the time of application for recognition and display the same on the notice board of the school and shall not increase the fees during the any academic session. In case of any change in the fee structure the school shall inform to the appropriate authority in the month of January for the next academic year and will also issue printed receipts of fees/funds to the students.
4. Salary shall be paid as per declaration at the time of seeking recognition.
5. No capitation fee and other charges shall be charged from the children/parents.
6. School shall be open for admission without any discrimination based on religion, caste, race, place of birth or any other whimsical.

श्री विनोद कुमार, लिपिक, तत्कालीन कार्यालय जिला मौलिक शिक्षा अधिकारी, सोनीपत अब रा0व0भा0वि0 अगवानपुर (सोनीपत) को निदेशालय के आदेश क्रमांक 5/117-2011 एच.आर.एम.ई.(1) दिनांक 25.04.2012 को निलम्बित किया गया था और दिनांक 24.09.2013 को लम्बित जांच बहाल किया गया था। कर्मचारी के विरुद्ध दिनांक 13.09.2012 को नियम-7 के तहत चार्जशीट जारी की गई थी। जिसमें निम्नानुसार आरोप लगाए गए थे:-

1. यह कि श्री विनोद कुमार, लिपिक को कार्यालय की स्थापना फाईल (लिपिक/चतुर्थ श्रेणी कर्मचारियों की) सीट का पूर्ण चार्ज दिनांक 25.07.2007 को लिया था। इस सीट का चार्ज सम्बंधित सहायक को देने बारे जिला शिक्षा अधिकारी सोनीपत के कार्यालय द्वारा अनेक बार लिखा गया। परन्तु आप द्वारा जिला शिक्षा अधिकारी सोनीपत के आदेशों की अवहेलना करते हुए कोई भी रिकार्ड/चार्ज दिनांक 10.07.2012 तक नहीं दिया।
2. यह कि श्री विनोद कुमार, लिपिक द्वारा कार्यालय की स्थापना 5 सीट से सम्बंधित का चार्ज न देने के कारण आर0टी0आई0 के तहत स्था0 5 सीट से सम्बंधित मांगी गई सूचना का कार्यालय रिकार्ड में प्राप्त न होने के कारण मामला सूचना आयोग तथा माननीय पंजाब व हरियाणा उच्च न्यायालय, चण्डीगढ़ में गया जिसके कारण विभाग की छवि खराब हुई तथा विभाग को कठिनाईयों का सामना करना पडा।

कर्मचारी द्वारा उक्त चार्जशीट का उत्तर निदेशालय में नहीं दिया, दिनांक 30.07.2013 को श्री वी0जी0 गोयल, सेवानिवृत्त, एच0सी0एस0 को जांच अधिकारी नियुक्त किया गया। जांच अधिकारी द्वारा अपनी जांच रिपोर्ट निदेशालय में दिनांक 20.11.2013 को प्रस्तुत की गई, जिसमें कर्मचारी पर लगाए गए आरोप पूर्णतः साबित होते हैं। दिनांक 20.01.2014 को जांच रिपोर्ट कर्मचारी को भेजकर उस पर टिप्पणी देने बारे लिखा गया, कर्मचारी ने जांच रिपोर्ट पर टिप्पणी न देते हुए दिनांक 29.06.2015 को निजी सुनवाई का अवसर मांगा। जिस अनुसार कर्मचारी को दिनांक 29.07.2015 को निजी सुनवाई का अवसर प्रदान किया गया। जिसमें कर्मचारी द्वारा कहा गया कि उस द्वारा कार्यालय जिला शिक्षा अधिकारी, में बहुत बार Contact किया गया, परन्तु जिला शिक्षा अधिकारी कार्यालय द्वारा उनकी कोई सुनवाई नहीं की गई। इसलिए उनका मामला नरम रूख अपनाते हुए देखा जाए।

अतः उपरोक्त वर्णित स्थिति में जांच अधिकारी द्वारा दी गई जांच रिपोर्ट और निजी सुनवाई पर कर्मचारी द्वारा कहा गया कि उस पर लगाए गए आरोप निराधार हैं, उसे आरोप मुक्त किया जाए के दृष्टिगत, मैं सक्षम अधिकारी होने के नाते, कर्मचारी की नियम-7 की चार्जशीट को नियम-8 में परिवर्तित करते हुए, श्री विनोद कुमार, लिपिक रा0व0भा0वि0 अगवानपुर (सोनीपत) की एक वार्षिक वेतन वृद्धि असंचित प्रभाव से रोकने के आदेश पारित करता हूँ।



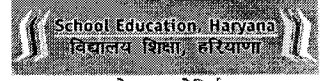
