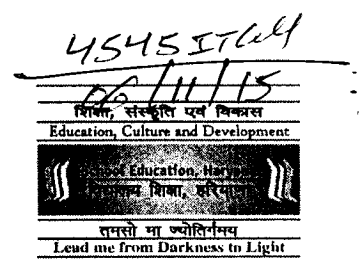

**Terms and Conditions**

1. The lecturer so appointed are advised to report in the Directorate through the concerned District Education Officer if they find that the post against which they are being appointed is not vacant in the school so that they are adjusted at some other place.
  - b. That no male teacher below the age of 50 years will be allowed to join in any Girls' School.

- c. That no lecturer is being posted at any urban place by default or any oversight on the part of Directorate.
- d. That this promotion is further subject to the condition that these promoted lecturer is in the possession of the post graduate degree with atleast 50% marks in their respective subjects. It shall be obligatory for the District Education Officers and Principals of the Senior Secondary Schools to ensure the verification of the post graduate degrees possessed by this lecturer. He shall be personally liable for any lapse in this regard. Their verification reports must reach the Directorate before 04/12/2015 positively failing which it shall be presumed that the necessary verification has been carried out by them and newly promoted lecturers have been found to be eligible as per rules. Hence, in the event of any subsequent revelation to the contrary, they shall be held personally liable.
- e. That it must be ensured that there exists a sanctioned post and requisite work load in the school where this lecturer is being posted.
- f. That this promotion is subject to the condition that there is no adverse remark pertaining to integrity in the ACRs of these newly promoted lecturer.

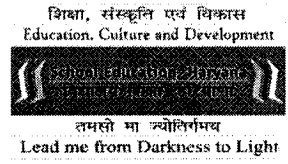

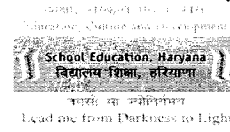

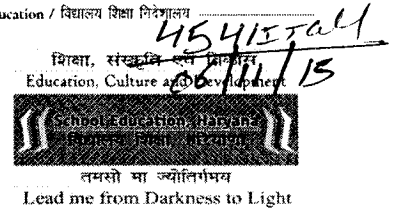
