Subject: Regarding seeking permission for joining as Principal in GSSS, Titoli  
(Rohtak) – Shri Ved Singh Sahrawat.

Reference this office Memo No.6/16-2014 HRG-II(1) dated 14.1.2015 on the subject cited above.

Shri Ved Singh Sahrawat, Principal was reverted to the post of Sanskrit teacher vide this office order dated 25.1.2014. He had challenged his reversion order in Review Application No.149 of 2014 and the Hon'ble High Court stayed his reversion orders. Subsequently, one Shri Bahadur Singh, Headmaster, had filed SLP (C) No.15822-23 of 2014 and the Hon'ble Supreme Court stayed the operation of stay order of High Court on 16.7.2014. Thus, the reversion order passed by the department was to be implemented and Shri Ved Singh Sahrawat was relieved and directed to join as Sanskrit teacher vide this office order No.6/16-2014 HRG-II(1) dated 12.8.2014.

Thereafter, the Supreme Court vacated its own stay order on 08.12.2014 and the stay order passed by the High Court again became operational. Consequently, Shri Ved Singh Sahrawat, Principal, GSSS, Humanyupur (Rohtak) was again allowed to join as Principal vide this office order dated 14.1.2015 and was adjusted in GSSS, Titoli (Rohtak) as the post of Principal in GSSS, Humanyupur (Rohtak) was not vacant.

Meanwhile, Shri Ved Singh Sahrawat had retired on 31.12.2014 and he had joined as Sanskrit teacher in GSSS, Chamarian (Rohtak) only three days before his retirement. He has sought information as to from which school he should submit his pension papers.

It is requested that the pension papers of Shri Ved Singh Sahrawat, Principal be forwarded through Principal, GSSS, Titoli (Rohtak) immediately to avoid any hardship to the officer and the Principal GSSS, Titoli (Rohtak) is declared as DDO for granting retiral benefits to Shri Ved Singh Sahrawat and further correspondence in future.
