
The factual matrix of the case are that a complaint under Section 323, 325, 326, 506, 34 of IPC was filed by complainant Bansilal against Sh. Inder Singh, Headmaster, GHS, Kaimri(Hissar) and others. Further, he was convicted by the court of Sh. Sudeep Goel, Addl. Chief Judicial Magistrate, Hissar vide order dated 28.10.2014 and sentenced 'to rigorous imprisonment for two years and to pay fine of Rs. 500/-'. It was further directed that in default of payment of fine, the said convict Inder Singh shall further undergo simple imprisonment for a period of 15 days. The said incumbent filed an appeal against the order dated 28.10.2014 and Additional Session Judge, vide order dated 21.11.2014 suspended the sentence during the pendency of the appeal.

2. In view of above judgement and instructions dated 08.07.1957 issued by Punjab Government Circular Letter No. 4819-G II-57/11919, it is incumbent upon the competent authority to take a decision, as to whether the conviction under Section 326 falls within the ambit of offences involving moral turpitude, before inflicting a penalty prescribed in proviso (a) to Article 311(2) of the Constitution of India. Now, the competent authority i.e. Principal Secretary School Education has approved in principle that the said conviction in the present case does not fall in the category of offences involving moral turpitude and has further directed Director Secondary Education to inflict a suitable minor penalty upon the said incumbent as provided in Appendix C read with Rule 14(1) of Haryana State Education School Cadre (Group B) Service Rules, 2012.

3. I have gone through the contents of the entire file, judgement of Addl. Chief Judicial Magistrate, Hissar dated 28.10.2014, Additional Session Judge order dated 21.11.2014 in appeal, instructions dated 08.07.1957 issued by Punjab Government Circular Letter No. 4819-G II-57/11919 and Haryana State Education School Cadre (Group B) Service Rules, 2012, para 14 of the book published by the Law and Legislative Department containing guidelines regarding procedure in Disciplinary matter and connected provisions of Article 311(2) of the Constitution of India. So far as the suspension of sentence in appeal is concerned, this has no affect in inflicting a penalty in view of the fact

that the conviction has not been stayed and also as clarified in the instructions dated 08.07.1957(supra). However, there is no denying the fact that the said incumbent has been convicted and sentenced for two years.

Taking an overall view of the matter, a penalty of stoppage of two grade increments without cumulative effect is inflicted upon Sh. Inder Singh, Headmaster, GHS, Kaimri(Hissar), as provided in Rule 4(1)(v) of the Haryana Civil Services (Punishment & Appeal) Rules, 1987.

Disciplinary matter of Shri Ajmer Singh, Headmaster, Government Girls High School, Bharan (Rohtak) under Rule 8 of the Haryana Civil Services (Punishment & Appeal) Rules, 1987 was decided by the Director Secondary Education, Haryana vide order dated 09.05.2014 imposing a penalty of stoppage of one grade increment without cumulative effect. Appeal against the same was dismissed by Principal Secretary to Govt. of Haryana, School Education Department vide order no. 5/34-2012 HRGII(4), dated 16.01.2015. The said incumbent was placed under suspension vide order dated 17.07.2012 and further reinstated vide order dated 10.09.2012/17.09.2012. For deciding the suspension period from 18.07.2012 to 19.09.2012, a show cause notice was issued vide Memo No. 5/34-2012 HRG-II(4), dated 05.02.2015 on the following grounds: -

1. Why the pay and allowances for the suspension period be not restricted to whatever has been paid during the suspension period?
 2. Why the suspension period be not treated as non-duty period?
2. As a consequence thereof, he made representation dated 09.06.2015, wherein he requested that he has not misbehaved with the senior officers during counseling held on 18.07.2012, wherein his wife was also a candidate for the post of Post Graduate Teacher. He also requested therein that his suspension period may be treated as duty period. After going through the order dated 09.05.2014 passed by Director Secondary Education, order dated 16.01.2015 passed by Principal Secretary to Govt. of Haryana, School Education Department in appeal, show cause notice dated 05.02.2015, reply thereof, relevant provisions of The Punjab Civil Services Rules Volume I Part I and Government instructions issued from time to time in this regard, it is clear that the said incumbent has flouted all norms of discipline, decorum and decency, being the basic ingredients expected of a Teacher in counseling held for allocating stations to various newly recruited/appointed Post Graduate Teachers, wherein his own wife was also a candidate. Already by taking a lenient view, just a penalty of stoppage of one grade increment without cumulative effect was inflicted upon him by the Competent Authority. It was incumbent upon his part to have maintained high standards of discipline, which he has been completely lacking in. Moreover, his case and appeal has been decided on merits which cannot be re-opened by the undersigned at this stage as no plausible reason has been given by him for treating the suspension period as duty period.

In the light of above, period of suspension from 18.07.2012 to 19.09.2012 shall be treated as not spent on duty period for all intents and purposes including treating the same as non-qualifying service for retiral benefits. Further, he shall not be paid more than whatever has already paid to him as subsistence allowance during the said suspension period.
