ORDER NO. 13/36-2015 HRL (4)

DATED, CHANDIGARH, THE 2/10/2015

Whereas Sh. Rajesh and other had filed CWP No. 2551 of 2015 in the Hon'ble Punjab and Haryana High Court and prayed therein to issue appointments to the petitioners as PGT Sociology and grant them pay and all other allowances w.e.f. 14.12.2013. This writ petition was disposed of by the Hon'ble Court on 13.02.2015 with the following directions:-

"Having heard the learned counsel for the petitioners and without expressing any opinion on the merits of case, lest it should prejudice the rights of either of the parties, Principal Secretary, Department of School Education, Haryana-respondent No. 1, is directed to look into the matter, consider the grievance of the petitioners raised vide their legal notice dated 22.12.2014 (Annexure P-7A) and decide the same at an early date, by passing an appropriate order thereon, strictly in accordance with law, but in any case within a period of three months from the date of receipt of a certified copy of this order. With the above-said observations made and directions issued, the present writ petition stands disposed of."

2. In compliance of the aforesaid directions of the Hon'ble Court, the legal notice of the petitioner dated 22.12.2014 has been considered and the following facts have emerged. The Haryana School Teacher's Selection Board, Panchkula advertised the posts in different subjects of PGT on 07.06.2012 and the name of the petitioner Smt. Sumiti D/o Sh. Shamsher Singh was recommended for appointment as Post Graduate Teacher in Sociology, Merit No. 90 by the Haryana Staff Selection Commission, Panchkula vide letter No. 2/1/2013-HSTSB/2013/CA dated 20.03.2013. While recommending the names of selected candidates the Haryana School Teachers Selection Board, Panchkula had made the following observations:-

"The selected candidate has not been medically examined and no special enquiry into her antecedents has been made. The documents pertaining to her qualifications, 4 Year Experience, age, caste/category and Universities as claimed by her in the application form may please be got checked/ verified from the issuing authorities, before she is allowed to join her duty. A copy of the appointment letter issued to the candidate may also be endorsed to the Board."

3. In view of the above observations of the Haryana School Teachers Selection Board, Panchkula different committees to verify the experience certificate and other documents of the selected candidates were constituted. During verification of experience certificate of the petitioner Mrs. Sumiti, Committee found that experience certificate issued by the Hindu Sr. Sec. School, Garhi Kesri, Ganaur (Sonepat), which was the basis of the selection of the petitioner, was not in order.

4. It is pertinent to mention here that a special relaxation was provided under Rule 7 of Haryana State Education School Cadre, Group B, Service Rules, 2012 in HTET to those candidates who have worked as a teacher for a minimum period of four years on the date of enforcement of these Rules. The relevant extract of the Rules are given here as under:-

Further, note 1 below Appendix-B says (in case of Direct recruitment the teachers working in Privately managed Govt. Aided, Recognised and Government Schools, are exempted to acquire qualification of passing HTET as described in column 3 if they have worked as a teacher for a minimum period of 4 years on the date of enforcement of these rules. However, the said exemption is as a one-time measure and the said category of teachers on their appointment shall have to qualify HTET by not later than 1st April, 2015 later on the same has been extend upto 1st April, 2018 otherwise their appointment shall stand terminated automatically without giving any further notice.

5. Since, the eligibility of the petitioner for selection as PGT Sociology was determined on the basis of experience certificate, consequently a Show Cause Notice vide memo No. 6/4-2013 HRL (4) dated 21.06.2014 was served upon her that why her candidature may not be recommended for cancellation to the appropriate authority in view of the observations of the committee. It was also observed that the experience certificate of the petitioner is not as per prescribed norms of the department in view of students strength. The petitioner replied to the show cause notice on 02.07.2014. Reply was duly considered and thereafter, the petitioner was afforded an opportunity of personal hearing. She appeared before the then Additional Chief Secretary to Government Haryana, School Education Department on 26.07.2014. Even at the time of personal hearing, she failed to prove the genuineness of the experience certificate.

6. Thereafter, a Show Cause Notice vide memo No. 6/4-2013 HRL (4) dated 22.10.2014 was also served upon to the school concerned to prove the genuineness of the teaching experience certificate issued to the candidate concerned. The school management submitted its reply to the show cause

notice on 20.11.2014, which was duly considered by the departmental committee, but found unsatisfactory being devoid of any merit in it.


7. Details of students appeared from said school in the 10+2 examination during 01.01.2008 to 22.06.2012 when teaching experience of the petitioner was issued is given as under:-

As per the students strength during the above period, teaching experience, issued to the petitioner appears to be neither genuine nor justifiable. Thus, she does not deserve appointment on the basis of the above experience certificate.

In view of the position enunciated above, Smt. Sumiti D/o Sh. Shamsheer Singh, provisionally recommended for appointment to the post of PGT Sociology, cannot be appointed to the post recommended.

Ordered accordingly.



Note :-

- 1 The official will be relieved immediately and in any case within 3 days failing which he/she will be liable for disciplinary action, However if any official is working in Census duty, he/she shall not be relieved till the Census duty is accomplished.
- 2 No TA/DA and joining time will be admissible to the official if he/she has been shifted on his/her request after exercising option.
- 3 No male teacher below the age of 50 years be allowed to join in the girls schools.
- 4 If there is no vacancy in the destination school for any reason the incumbent transferred shall re-join his/her previous place of posting and also inform to concerned branch/computer cell at HQ.
If any discrepancy is noticed in this order or there is a violation of transfer policy, It should be brought to the notice of Computer Cell/Concerned branch within three days and the order be not implemented.
- 5 In case of mutual transfer, it is directed that before relieving/joining the officials concerned, it may be ensured that the distance between both the schools is not less than 8 km.
- 6 In case of urban area stations while implementing the transfer orders, it may be ensured that the transferee has completed the rural service as per transfer policy.
- 7 The mutual transfer would be effective only when both the employees seeking mutual transfer submit a consent document to their respective Principals.
