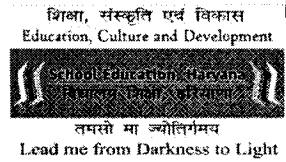

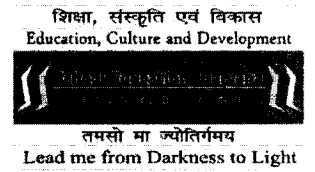



2. यह कि श्री सतीश कुमार, आंकडा सहायक बिना किसी लिखित सूचना/प्रार्थना पत्र के लम्बे समय तक कार्यालय से अनुपस्थित रहे।
3. यह कि श्री सतीश कुमार, आंकडा सहायक को जि0शि0अ0 सोनीपत की सीट जी-3 का कार्य दिया गया था जो कि काफी लम्बे समय से लम्बित पडा रहा तथा बार-2 सूचना मांगने पर भी सूचना न भेजने के कारण विभाग की छवि खराब हुई जिसके लिए वह जिम्मेवार है।
4. यह कि श्री सतीश कुमार, आंकडा सहायक का स्थानांतरण जि0शि0अ0 सोनीपत के कार्यालय से जि0शि0अ0 नारनौल जिला महेन्द्रगढ के कार्यालय में प्रशासनिक आधार पर किया गया था। परन्तु उनके द्वारा अपने उच्च अधिकारियों के आदेशों की अवहेलना की जिसके लिए वह स्वयं जिम्मेवार है।

कर्मचारी ने चार्जशीट का जवाब नहीं दिया। तदोपरात श्री एच0पी0 चौधरी सेवानिवृत्त आई0ए0एस0 को निदेशालय के पत्र दिनांक 02.01.2015 द्वारा जांच अधिकारी नियुक्त किया गया। जांच अधिकारी ने अपनी जांच रिपोर्ट, दिनांक 28.04.15 में कर्मचारी पर लगे आरोपों को पूर्णतः प्रमाणित किया गया। आरोपित को नियमानुसार पत्र दिनांक 27.05.2015 द्वारा जांच रिपोर्ट की प्रति प्रतिवेदन देने के लिए भेजी गई। कर्मचारी ने दिनांक 27.05.15 को जांच रिपोर्ट पर प्रतिवेदन दिया जिसमें उसने सभी आरोपों को नकारा। तदोपरान्त कर्मचारी को दिनांक 9.9.15 को निजी सुनवाई का अवसर प्रदान किया गया। तब भी कर्मचारी द्वारा कोई भी नया तथ्य पेश नहीं किया। आरोपों को नकारा गया।

उपरोक्त वर्णित स्थिति, जांच अधिकारी द्वारा दी गई जांच रिपोर्ट, कर्मचारी के उत्तर व उस द्वारा निजी सुनवाई के समय दिये गये तथ्यों तथा रिकार्ड के आधार पर यह निष्कर्ष निकलता है कि आरोपित पर लगाये गये आरोप सत्य हैं तथा मैं, सक्षम अधिकारी होने के नाते कर्मचारी की एक वार्षिक वेतनवृद्धि असंचित प्रभाव से रोकने का कारण बताओ नोटिस जारी करने के आदेश पारित करता हूँ।
