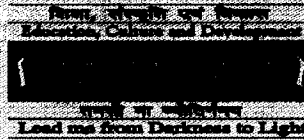

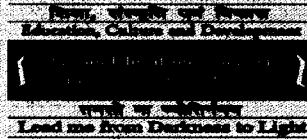

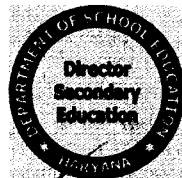

1. 2. The school shall follow the course of study as per syllabus prescribed by the affiliated board.
3. हरियाणा विद्यालय शिक्षा बोर्ड, भिवानी द्वारा सूचित किया गया था कि बोर्ड कार्यालय के अधिकारियों द्वारा दिनांक 17-12-2013 को न्यू एम0ई0डी0 व0 मा0 वि0, अटेला (भिवानी) का निरीक्षण किया गया। निरीक्षण के दौरान अटेला गांव में कोई न्यू एम0ई0डी0 व0 मा0 वि0, अटेला (भिवानी) नहीं था। गांव के लोगो से पूछताछ पर पता चला कि इस विद्यालय के स्थान पर श्री कृष्ण कालेज ऑफ एजुकेशन, अटेला नाम से चल रहा है। इस कालेज में स्कूल के नाम से कोई भवन अलग से भी नहीं है। इस प्रकार सम्बन्धित विद्यालय द्वारा शिक्षा विभाग हरियाणा के मान्यता/ सम्बद्धता विनियमों की अवहेलना की गई है।

जिला शिक्षा अधिकारी, भिवानी द्वारा भी सूचित किया गया है कि विद्यालय दसवीं कक्षा तक स्थाई मान्यता प्राप्त है। खण्ड शिक्षा अधिकारी, चरखी दादरी की जांच उपरान्त तथ्य सामने आए है कि विद्यालय में कक्षाएं नहीं चल रही है और विद्यालय की मान्यता तुरन्त प्रभाव से रद्द करने की सिफारिश की गई है। हरियाणा विद्यालय शिक्षा नियम 2003 के अनुबन्ध 43 में (ग) में स्पष्ट उल्लेख है कि:-

“ यदि विद्यालय की प्रबन्धक समिति, धोखे से, दुर्व्यपदेशन या किन्ही ब्यौरो का छिपाते हुए मान्यता प्राप्त करती है या मान्यता प्राप्त करने के बाद, इन नियमों में विनिर्दिष्ट किन्ही शर्तों का पालन करने में असफल रहती है, तो समुचित प्राधिकारी, सुनवाई का युक्तियुक्त अवसर देने तथा प्रस्तावित कार्यवाही के विरुद्ध एक माह का कारण बताओ नोटिस देने के बाद मान्यता वापिस ले सकता है।”

उक्त वर्णित तथ्यों के दृष्टिगत प्रबन्धक, न्यू एम0ई0डी0 व0 मा0 वि0, अटेला (भिवानी) को दिनांक 06-02-2014 के तहत कारण बताओ नोटिस जारी किया गया था, परन्तु उपरोक्त संस्था द्वारा कारण बताओ नोटिस का कोई जवाब प्रस्तुत नहीं किया गया। इससे सिद्ध होता है कि विद्यालय समिति को इस बारे कुछ भी नहीं कहना है। इस प्रकार नियमानुसार एक तरफा कार्यवाही करते हुए न्यू एम0ई0डी0 व0 मा0 वि0, अटेला (भिवानी) को निदेशालय यदि क्रमांक 23/582-2001वि0 (1) दिनांक 19-10-2001 के तहत जारी की गई मान्यता व निदेशालय के यदि क्रमांक 24/128-2003 वि0 (3) दिनांक 01-10-2003 के तहत कक्षा 11 से 12 वीं के लिए जारी की गई अनुमति 01-04-2015 से निरस्त की जाती है। तदनुसार आदेश पारित करता हूँ।
