**NO. 16/34-2007 HRL (1)**

**DATED, CHANDIGARH, THE 17.03.2015**

In compliance of order dated 24.04.2014 passed by the Hon'ble Punjab and Haryana High Court vide which the incumbent has been acquitted of the charges framed against Sh. Manjeet Singh by giving the benefit of doubt on/the grounds that the prosecution have failed to prove the guilt of the accused beyond reasonable doubt. Now, Sh. Manjeet Singh is hereby reinstated in service and posted at GMSSS Sanghi (Rohtak) [2681] against vacant post with immediate effect. Further, he will be entitled to the wages from the date he lodged the demand i.e. 26.05.2014, as has been held by the Hon'ble Apex Court in a similar case in Civil Appeal No. 5472 of 2013 titled as State Bank of India and another Vs. Mohammed Abdul Rahim decided on 17.07.2013, cited in 2013 (4) RSJ 614. However, he will not be entitled for the period from date of dismissal i.e. 28.05.2007/30.05.2007 till date of acquittal by the Hon'ble High Court i.e. 24.04.2014, as has been held in a similar case by the Hon'ble Apex Court in Civil Appeal No. 8565 of 2003 titled as Union of India and others Versus Jaipal Singh, cited in 2003 Supp (5) SCR 115. Furthermore, as has been held by Hon'ble Apex Court in the said judgement, the period from 28.05.2007/30.05.2007 till 24.04.2014 of the incumbent shall have to be counted as period of service without any break.
