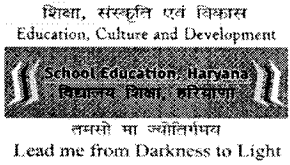

Terms and conditions:-

1. She is appointed purely on temporary basis.
2. This appointment is against temporary posts and her confirmation against substantive posts shall be considered on the basis of her seniority and record of service as and when such post is available.
3. She shall have to take an oath of allegiance to the Constitution of India.
4. In case she is married, she shall produce a certificate, before joining the duty, to the effect that she has only one living spouse. 

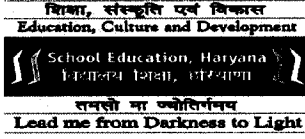

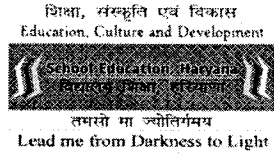
