

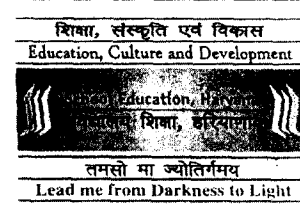

In compliance with the order dated 30.9.2014 passed by the Hon'ble Punjab and Haryana High Court in civil writ petition No.6865 of 2009 titled as Tejender Pal Singh versus State of Haryana and others, the Governor of Haryana is pleased to appoint the following person as Headmaster in Government High School under the provisions of the Haryana State Education (School and Inspection Cadre) (Group B) Service Rules, 1998, in the pay scale of Rs. 7500-250-10000-EB-250-12000 plus usual allowances as admissible under the State Government Rules from time to time.

The candidate is directed to join his place of posting mentioned against his name within 15 days from the date of receipt of this order on the following terms and conditions :-

1. He is hereby appointed as Headmaster w.e.f. 25.01.2008 i.e. the date from which the candidate junior to him was appointed as such. The benefit of ante-dated appointment will be admissible to him only for the purpose of seniority and continuity in service and actual financial benefits will be admissible to him from the date he joins duty as High School Headmaster.
2. He is appointed purely on temporary and provisional basis.
3. This appointments is against temporary post and his seniority and record of substantive post shall be considered on the basis of his seniority and record of service as and when such posts is available.
4. He shall have to take an oath of allegiance to the Constitution of India.
5. He shall produce a certificate before joining the duties to the effect that he has one living wife in case he is married. The candidate who has more than one living wife/husband, shall not be eligible for appointment to the post offered unless the Government after being satisfied that there is special grounds for doing so, exempt him from this condition.
6. He will not be allowed to apply for any post outside the department for a period of at least five years.
7. He shall be on probation for a period of two years. The period of probation can be extended for a further period not exceeding one year, if considered necessary.
8. In other matters, not specifically mentioned in this communication, he will be governed by the Civil Services Rules as applicable to Haryana

Government Employees and such orders/instructions as may be issued by the Government from time to time.

9. In case of reserved category candidate, the appointment is provisional and is subject to the Scheduled Castes/ Scheduled tribes and Backward Class Certificate being verified through the proper channels. If the verification reveals that the claim of belonging to SC/ST and BC, as the case may be, is false then his services will be terminated forthwith without assigning any further reason and without prejudice to such further action as may be taken under provisions of the Indian Penal Code for production of false certificate.
10. It is made clear that character and antecedents have not been got verified before issue of the appointment letter to the appointee and in case subsequently any adverse fact comes to the notice of the State Government/ Department regarding his character and antecedents, his services shall be terminated without any notice.
11. He is hereby directed to show his original certificate of academic qualification, experience and other relevant certificates to the concerned the District Education Officer of his place of posting. The District Education Officer would verify the genuineness of his original certificates and accordingly, give a certificate to this effect. The District Education Officer will also ensure that the candidates submits his medical fitness certificate first duly issued by the Medical Board only then he should join as Headmaster in the respective school of posting. The District Education Officer will also give character and antecedent's verification forms to him and after getting them filled in by him, the same be sent to the Directorate through a special messenger within a week's time. This is the personal responsibility of the concerned District Education Officer.
12. If he is already in Government job as Class-II officer, need not submit a fresh Medical fitness report whereas others are directed to appear before the Medical Boards as may be constituted by the Director General Health Services, Haryana, Panchkula and medical fitness report is to be submitted in the office of the concerned District Education Officer before joining the place of posting as Headmaster in respective Government High School.
13. He will be governed by the Haryana State Education (School and Inspection Cadre) (Group-B) Service rules, 1998 as amended from time to time.
14. If at any time during the course of his temporary appointment, he desires to resign he shall be required to give one month's clear notice or forfeit, in lieu thereof, his salary including allowances etc. for one month or for the period by which the notice falls short of one month. Such a notice will be given to him by the Government also in the case if it is proposed to terminated his services in lieu thereof. The Government will be liable to pay him salary, including allowances for one month or for the period by which the notice falls short of one month.
15. No TA/DA will be admissible to him for joining as Headmaster.
16. If he gets an appointment as Headmaster on the basis of his furnishing false or fraudulent information/ facts which is detected later on, his services would be liable for termination without any notice.

If he is willing to accept this offer of appointment as Headmaster, HES-II (School Cadre) on the above terms and conditions, he should submit his joining report as per aforesaid directions.


