16. School will provide ramp within six months otherwise recognition will stands withdrawn.

18. That the number of students in classroom shall not be more than the students calculated on the 10 square feet per student for secondary and Senior Secondary Schools and 9 Square feet per student for elementary state.

5. The salary will be paid as per provisions of CSR Vol-II i.e. last pay drawn minus pension.


