

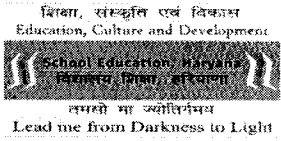

TERMS & CONDITIONS:-

1. 2. The school shall follow the course of study as per syllabus prescribed by the affiliated board.
3. In case of any change in the fee structure the school shall inform to the appropriate authority in the month of January for the next academic year and will also issue printed receipts of fees/funds to the students.
