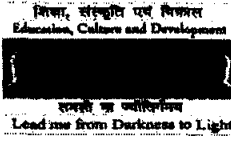

It is, thus made clear to him that at present he has been offered temporary post.
2. He will give such a notice also in case, it is proposed to terminated his services for the reason other than that mentioned in clause (1) above.
3. His seniority amongst peons will be determined from the date he resume duty in the office.
4. He will not undertake higher studies of any kind without prior permission of the competent authority. Consequently no leave of any kind will be granted for perusing the higher studies.
5. He will remain on probation for a period of two years from the date of joining in the Department. The period of probation can be extended in accordance with the existing rules on the subject. For assessing his performance during the period of probation his work and conduct will be taken into consideration.

If his work and conduct during the probation is not found satisfactory, his services will be terminated forthwith without assigning any reason.

6. No TA/DA or joining time will be paid to him for joining this post.

If he is willing to accept the offer made on the above mentioned conditions, he may get himself be relieved and report for duty to the office of Director Secondary Education, Haryana, Shiksha Sadan, Sector-5, Panchkula within a period of 15 days from the issue of this letter.


