

Memo No 6/101-2013 HRG-II (2)
Dated, Panchkula, the 25-03-2015

Sub. CWPs No 8082 of 2001 titled R.K. Verma & others Vs State of Haryana & others and CWP No 13897 of 2003 titled Sachidanand & others Vs State of Haryana & others.

With reference to the subject cited above.

Whereas CWPs No 8082 of 2001 titled R.K. Verma & others Vs State of Haryana & others and CWP No 13897 of 2003 titled Sachidanand & others Vs State of Haryana & others were decided by Hon'ble Punjab & Haryana High Court vide order dated 1-12-2010. The operative part of order is as under:-

"In view of the ratio of law laid down by the full Bench of this Court, prayer made by the petitioner in these two writ petition is accepted: order Annexure P-3, to the extent it grants revised pay scale to Headmaster/Headmistress with effect from 1-8-2000, is quashed and directions is issued to the respondents to grant revised pay scale of Rs, 7500-12000 to the petitioners with effect from 1-1-96, the date when the anomaly arose. However, it is made clear that the respondents shall remove anomaly and fix the pay of the petitioners notionally with effect from 1-1-96, on which date it arose. However, the arrears of pay are restricted to 38 months from filling of the writ petition. CWP No 8080 of 2001 was filed on 25-5-2001 whereas CWP No 13897 of 2003 was filed on 1-9-2003. The petitioners have retired by now, their terminal benefits shall be also disbursed within six months."

Against the above order, LPA Nos 951-952 of 2012 were filed by the State in the Hon'ble Punjab & Haryana High Court and same were dismissed on 31-10-2012. Thereafter, State filed SLP No CC-19054-19055 of 2013 against the order dated 31-10-2012 passed in LPAs which were also dismissed by Hon'ble Apex Court vide order dated 1-11-2013. Further Review Petition Nos 2661-2662 of 2014 were filed and same were also dismissed by Hon'ble Apex Court on 2-12-2014.

In the light above facts, matter has been re considered and it has been decided to implement the order dated 1-12-2010. Headmasters (High schools) are hereby granted the pay scale of Rs. 7500-12000 w.e.f. 1-1-96 notionally and actually from prospective effect. However the arrears of pay for petitioners only are restricted to 38 months from the date of filing the writ petition. The other Head Masters will not be entitled to any arrears. Concurrence of Finance Department has been obtained vide UO NO 6/76/2010-4PR(FD) dated 16-3-2015 in this regard.

These instructions may be brought to the notice of all concerned DDOs for compliance. Pay be re fixed after verification of Section Officer concerned.
